IN THE MATTER OF THE APPLICATION OF BLENN GULSTROM FOR THE APPROVAL OF A CHANGE IN POINT OF DIVERSION OF WATER FROM SOUTH FORK COQUILLE RIVER

ORDER APPROVING TRANSFER NO. 2441

On September 2, 1970, Glenn Gulstrom filed an application in the office of the State Engineer for the approval of a change in point of diversion of water from South Fork Coquille River, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Claud Walker and recorded at page 14649, Volume 12, State Record of Water Right Certificates, confirms a right to the use of 0.47 cubic foot per second of the waters of South Fork Coquille River for the irrigation of 6.0 acres in Lot 6 (NEX NWX) and 31.0 acres in Lot 6 (SEX NWX), Section 32, Township 29 South, Range 12 West, W.M., with a date of priority of May 15, 1939. These lands are irrigated from a point of diversion located 1400 feet south and 360 feet west from the NX corner of Section 32 being within Lot 6 (SEX NWX), Section 32, Township 29 South, Range 12 West, W.M.

The applicant herein, owner of the lands above described, proposes to irrigate these lands from a point of diversion to be located 840 feet north and 40 feet west from the E% corner of Section 31 being within Lot 4 (SE% NE%), Section 31, Township 29 South, Range 12 West, W.M.

Notice of the filing of the application was given by publication setting forth a time and place certain for hearing objections to the proposed change in point of diversion of water, if any there were, namely: at the county courthouse in Coquille, Oregon, on November

11, 1970, at 9:30 a.m. The notice was published in <u>Myrtle Point</u>

<u>Herald</u>, a newspaper printed and having general circulation in Coos

County, Oregon, for a period of three weeks in the issues of September 17, 24, and October 1, 1970. The date set for hearing in said notice was not less than thirty days after the last publication of the notice.

Mr. M. John Youngquist, Watermaster of District No. 15, has filed a report to the effect that the proposed change in point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in point of diversion of water from South Fork Coquille River, to-wit:

From a point located 1400 feet south and 360 feet west from the M¼ corner of Section 32 being within Lot 6 (SE¼ NW¼), Section 32, Township 29 South, Range 12 West. W.M.

To a point to be located 840 feet north and 40 feet west from the E% corner of Section 31 being within Lot 4 (SE% NE%), Section 31, Township 29 South, Range 12 West, W.M.

for the irrigation of 6.0 acres in Lot 6 (NE% NW%) and 31.0 acres in Lot 6 (SE% NW%), Section 32, Township 29 South, Range 12 West, W.M., with a date of priority of May 15, 1939, is approved.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1971.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion and shall not exceed 0.47 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be

effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices.

That the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled.

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that certificate of water right heretofore issued to Claud Walker and recorded at page 14649, Volume 12,

State Record of Water Right Certificates, is canceled and upon receipt
of proof satisfactory to the State Engineer of completion of the authorized change in point of diversion, a certificate of water right shall
be issued to Glenn Gulstrom confirming the change in point of diversion.
