ORDER APPROVING
TRANSFER S-102

On June 23, 1955, an application was filed in the office of the Water Resources Director by Squaw Creek Irrigation District for approval of changes in point of diversion of water from Squaw Creek, pursuant to the provisions of ORS 540.510 to 540.530.

By Decrees of the Circuit Court for Creek County, Oregon entered May 1, 1911 and September 19, 1914, in the Matter of the Determination of the Relative Rights to the Use of the Waters of Squaw Creek and Its Tributaries, water rights were tabulated in Volume 1, pages 121, 122, 124, 438, 445, and 472, Order Record of the Water Resources Director, for use of the waters of Squaw Creek for irrigation of certain lands within Squaw Creek Irrigation District, as evidenced by the certificates recorded at pages 263, 267, 269, 295, 296, 297, 302 and 850, Volume 1, pages 855, 980, and 1266, Volume 2 and page 2361, Volume 3, State Record of Water Right Certificates.

The authorized points of diversion are through the Cloverdale Canal from a point located 1,950 feet South and 100 feet East from the Northwest Corner of Section 28, being within the SW 1/4 NW 1/4 of Section 28, Township 15 South, Range 10 East, WM; through the Squaw Creek Canal, from a point located 1,322 feet North and 778 feet West from the Southeast Corner of Section 29, being within the SE 1/4 SE 1/4 of Section 29, Township 15 South, Range 10 East, WM; and through the Edgington Ditch, from a point located 1,190 feet North and 1,100 feet East from the Southwest Corner of Section 21, being within the SW 1/4 SW 1/4 of Section 21, Township 15 South, Range 10 East, WM.

The applicant herein, proposes to change the points of diversion therefrom, without loss of priority, to a single diversion point located 998 feet North and 1,211 feet East from the Southwest Corner of Section 21, being within the SW 1/4 SW 1/4 of Section 21, Township 15 South, Range 10 East, WM (Main Canal and Edgington Ditch).

No objections having been filed and it appearing that the proposed changes in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested changes in point of diversion, as described herein, without loss of priority, are approved.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old points of diversion under the subject rights.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgment of the watermaster it becomes necessary to install headgates and measuring devices:

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that NO time need be fixed for completion as the changes in point of diversion are completed.

It is FURTHER ORDERED that the aforesaid certificates not be canceled; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this and other orders, superseding certificates of water right shall be issued.
