ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves TRANSFER 6341 submitted by

WEYERHAEUSER (AURORA FOREST NURSERY)
6051 SOUTH LONE ELDER ROAD
AURORA, OREGON 97002

to use the waters of FIVE WELLS in the PUDDING RIVER BASIN for the purpose of the IRRIGATION AND FROST CONTROL OF 20.5 ACRES.

The right to be transferred, was perfected by performance under Permit G-10570 with a date of priority of JULY 29, 1985. The right is limited to 250 GALLONS PER MINUTE; BEING 115 GPM FOR IRRIGATION AND 250 GPM FOR FROST CONTROL, if available at the original wells; NW 1/4 NE 1/4, NE 1/4 NW 1/4, SECTION 18, T 4 S, R 1 E, W.M.; WELL 6 - 840 FEET SOUTH AND 470 FEET EAST, WELL 14 - 880 FEET SOUTH AND 120 FEET WEST, BOTH FROM THE NORTH 1/4 CORNER OF SECTION 18, or its equivalent in case of rotation, measured at the wells.

The new points of appropriation are located as follows:

NW 1/4 SE 1/4, SW 1/4 SE 1/4, SECTION 7, T 4 S, R 1 E, W.M.; WELL 10 - 2130 FEET NORTH AND 180 FEET WEST, WELL 5 - 1130 FEET NORTH AND 1330 FEET WEST, WELL 15 - 750 FEET NORTH AND 2400 FEET WEST, ALL FROM THE SE CORNER OF SECTION 7.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated from February 1 to September 30 of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use is as follows:


The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change is reported complete. The claim of beneficial use shall be submitted in accordance with the instructions in the transmittal letter.
2. The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water available from the original points of appropriation.
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. If needed to prevent injury to existing water rights, the wells at the new points of appropriation shall be constructed to the well construction standards in effect as of the date of this order and must include access ports.
5. Water shall be acquired from the same aquifer as the original points of appropriation.

When satisfactory proof of the completed change is received, a certificate confirming this water right will be issued.
