ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6492 submitted by

MARGARET AND CHRISTOPHER L. TOOLE
POST OFFICE BOX 58
GALES CREEK, OREGON 97117.

The right to be modified, as evidenced by a PORTION of Certificate 42167, was perfected under Permit 17618 with a date of priority of MARCH 19, 1947. The right allows the use of EILER CREEK, a tributary of GALES CREEK, for IRRIGATION OF 6.0 ACRES. This right is limited to 0.075 cubic foot per second, if available at the authorized point of diversion: SE $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 7, T 1 N, R 4 W, WM; 1480 FEET SOUTH AND 1480 FEET EAST FROM THE N $\frac{1}{4}$ CORNER, SECTION 7, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SE $\frac{1}{4}$ NE $\frac{1}{4}$ 1.8 ACRES
SECTION 7

SW $\frac{1}{4}$ NW $\frac{1}{4}$ 4.2 ACRES
SECTION 8

TOWNSHIP 1 NORTH, RANGE 4 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the place of use to:

NE $\frac{1}{4}$ NE $\frac{1}{4}$ 2.1 ACRES
SE $\frac{1}{4}$ NE $\frac{1}{4}$ 3.9 ACRES

SECTION 7
TOWNSHIP 1 NORTH, RANGE 4 WEST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1995.
2. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 42167 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
