## ORDER APPROVING AN ADDITIONAL POINT OF DIVERSION

Pursuant to ORS 537.211 after notice was given and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, PERMIT AMENDMENT NOTICE T-7439 submitted by

ROGUE RIVER VALLEY IRRIGATION DISTRICT and MEDFORD IRRIGATION DISTRICT 3139 MERRIMAN ROAD MEDFORD, OREGON 97501.

The first water use permit to be modified is Permit 1706 with a date of priority of JUNE 24, 1913. The permit allows the use of BEAR CREEK, a tributary of the ROGUE RIVER, for IRRIGATION, DOMESTIC, AND SUPPLEMENTAL IRRIGATION. The amount of water to which this permit is entitled is limited to an amount actually beneficially used and shall not exceed 100 cubic feet per second, if available at the authorized point of diversion: SW¼ SW¼, SECTION 19, T 37 S, R 1 W, WM; BEAR CREEK -NORTH 45° EAST, 1400 FEET FROM THE SW CORNER, SECTION 19, or its equivalent in case of rotation, measured at the point of diversion from the source.

The second water use permit to be modified is Permit 2993 with a date of priority of MAY 10, 1916. The permit allows the use of GRIFFIN CREEK, JACKSON CREEK, BEAR CREEK, ANTELOPE CREEK, AND ALL SOURCES REFERRED TO IN PERMITS E-19, 407 AND R-50, tributaries of the ROGUE RIVER, FOR IRRIGATION AND SUPPLEMENTAL IRRIGATION. The amount of water to which this permit is entitled is limited to an amount actually beneficially used and shall not exceed 95.25 cubic feet per second, being 16.0 cfs from Jackson Creek, 51.5 cfs from Griffin Creek, and 27.75 cfs from all other sources of supply, if available at the authorized points of diversion: among others, SW¼, SECTION 19, T 37 S, R 1 W, WM; BEAR CREEK - NORTH 45° EAST, 1400 FEET FROM THE SW CORNER, SECTION 19, or its equivalent in case of rotation, measured at the point of diversion from the source.

The third water use permit to modified is Permit 4951 with a date of priority of JUNE 18, 1920. The permit allows the use of LITTLE BUTTE, YANKEE, ANTELOPE, DRY, BEAR, ANDERSON, COLEMAN GRIFFIN, JACKSON HORN, WILLOW CREEKS AND OTHER SOURCES, for IRRIGATION AND SUPPLEMENTAL IRRIGATION. The amount of water to which this permit is entitled is limited to an amount actually beneficially used and shall not exceed 300 cubic feet per second, if available at the authorized points of diversion: among others, SW¼ SW¼, SECTION 19, T 37 S, R 1 W, WM; BEAR CREEK - NORTH 45° EAST, 1400 FEET FROM THE SW CORNER, SECTION 19, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other rights existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The Irrigation Districts propose to add an additional point of diversion in the NE¼ NW¼, SECTION 30, T 37 S, R 1 W, WM; BEAR CREEK - 445 FEET NORTH AND 135 FEET EAST FROM THE SW CORNER OF THE NE¼ NW¼, SECTION 30.

THIS CHANGE TO EXISTING WATER USE PERMITS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE PERMIT HOLDERS:

- 1. The quantity of water diverted at the new point of diversion, together with that diverted at the old points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.
- 2. The water user shall install and maintain a headgate, an inline flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- The water user or irrigation district shall operate and maintain the headgate and measuring device, as needed. The water user or irrigation district shall report total flow figures when requested by the Watermaster. The Watermaster may operate the headgate and monitor accuracy of the measuring device, as needed.
- 4. Water shall be acquired from the same surface water source as the original point of diversion.

Permits 1706, 2993, and 4951, in the names of Rogue River Valley Irrigation District and Medford Irrigation District, are amended as described herein. All other terms and conditions of the permits remain the same.
