IN THE MATTER OF THE APPLICATION OF JOHN R. WEST FOR APPROVAL OF CHANGES IN PLACE OF USE AND POINT OF DIVERSION OF WATER)))	ORDER APPROVING TRANSFER 4807

On June 30, 1981, an application was filed in the office of the Water Resources Director by John R. West for approval of changes in place of use and point of diversion of water from South Fork Little Butte Creek, pursuant to the provisions of ORS 540.510 to 540.530.

By Decree of the Circuit Court for Jackson County, Oregon, entered August 15, 1949, In the Matter of the Determination of the Relative Rights to the Use of the Waters of Little Butte Creek and Its Tributaries, a water right was established in the name of L. Tonn, tabulated in Volume 14, page 526, Order Record of the Water Resources Director, for use of the waters of South Fork Little Butte Creek for irrigation of, among other lands, a certain 8.0 acres in NE 1/4 NE 1/4, Section 4, Township 37 South, Range 2 East, WM, with a date of priority of 1904, as evidenced by the certificate recorded at page 45050, Volume 37, State Record of Water Right Certificates.

Water for the said right is diverted, through the Tonn Ditch, from a point located 2,324 feet South and 870 feet East from the Northwest Corner of Section 3, being within the SW 1/4 NW 1/4 of Section 3, Township 37 South, Range 2 East, WM.

The applicant herein, owner of the lands above described, proposes to sever the right from 2.0 acres of the aforesaid 8.0 acres and, without loss of priority, to irrigate in lieu thereof a certain 2.0 acres in NW 1/4 NE 1/4, along with the balance of the aforesaid lands in NE 1/4 NE 1/4, Section 4, Township 37 South, Range 2 East, WM, from a point of diversion located 700 feet South and 600 feet West from the Northeast Corner of Section 4, being within the NE 1/4 NE 1/4, Section 4, Township 37 South, Range 2 East, WM.

Notice of the application, pursuant to ORS 540.520(2), was published in the Mail Tribune, a newspaper printed and having general circulation in Jackson County, Oregon, for a period of three weeks in the issues of July 31, August 7 and 14, 1981.

David C. Hendrix, Watermaster, has filed a statement to the effect that the proposed changes in place of use and point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed changes in place of use and point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested changes in place of use and point of diversion, as described herein, without loss of priority, are approved.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available at the old point of diversion under the subject right.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1983.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1983.

It is FURTHER ORDERED that the certificate recorded at page 45050, Volume 37, State Record of Water Right Certificates, is canceled; and in lieu thereof a new certificate be issued covering the balance of the right NOT involved in this proceeding; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.
