ORDER APPROVING A CHANGE IN PLACE OF USE AND
POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6742 submitted by

JERRY WILSON AND MARILYN WILSON
C/O SOLOFLEX INC.

The right to be modified, as evidenced by Certificate 68205, was perfected under Permit G-10581 with a date of priority of NOVEMBER 13, 1985. The right allows the use of WELL, a tributary of the ROCK CREEK BASIN, for IRRIGATION OF 5.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.06 cubic foot per second, if available at the original well; NW¼ NW¼, SECTION 2, T. 1N., R. 2W., W.M.; 630 FEET SOUTH AND 780 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 2, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

NW¼ NW¼ 5.0 ACRES
SECTION 2
TOWNSHIP 1 NORTH, RANGE 2 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the PLACE OF USE to:

NW¼ NW¼ 5.0 ACRES
SECTION 2
TOWNSHIP 1 NORTH, RANGE 2 WEST, W.M.

The applicant proposes to change the POINT OF APPROPRIATION to:

NW¼ NW¼, SECTION 2, T. 1N., R. 2W., W.M.; 1165 FEET
SOUTH AND 932 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 2

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE
FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1997.
2. The quantity of water diverted at the new point of appropriation (well) shall not exceed the quantity of water lawfully available from the original point of appropriation.
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.
5. The former place of use shall no longer be irrigated as part of this water right.

Certificate 68205 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
