Conclusions of Law


The proposed changes in place of use in Transfer Application T-11189 satisfy the requirements of ORS 540.574(3) and 540.580 and the abandoned rights should be cancelled.

Now, therefore, it is ORDERED:

1. The proposed changes to the District's existing water right Certificates 74306, 76230, 85974, 74299, 74302, 74304, 77288, 85975 and 85976 are approved.
2. The right to the use of water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in the District's water rights, related decree, and the Final Order approving T-11189.

3. The portions of the water rights evidenced by Certificates 74341, 74338, 74331, 3748, 2795 and 19548 requested to be canceled are canceled. New certificates will be issued confirming the balance of the rights not modified by the Final Order.
4. The former places of use shall no longer be irrigated as part of these water rights.
5. The proposed changes shall be completed on or before **October 1, 2012**. A Claim of Beneficial Use and Final Proof Map shall be submitted by Farmers Irrigation District to the Department by **October 1, 2013**.
6. Certificates 74306, 76230, 85974, 74299, 74302, 74304, 77288, 85975 and 85976 are modified. The Department will issue superseding certificates describing the rights when it is determined that it is necessary for record keeping.
