ORDER APPROVING
TRANSFER NO. 3074

On June 28, 1974, Remi Coussens filed an application in the office of the State Engineer for the approval of a change in place of use of water from McKay Creek, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Remi Coussens and recorded at page 38662, Volume 30, State Record of Water Right Certificates, confirms a right to the use of not to exceed 0.75 cubic foot per second of water from McKay Creek for the irrigation of 6.4 acres in SW $\frac{1}{4}$ SW $\frac{1}{4}$, 13.4 acres in SE $\frac{1}{4}$ SW $\frac{1}{4}$, 4.0 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$, 1.9 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 12; 6.7 acres in NE $\frac{1}{4}$ NE $\frac{1}{4}$, 13.8 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$, 9.0 acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$ and 4.4 acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 13, Township 1 North, Range 3 West, W.M., with a date of priority of February 11, 1953.

The applicant herein, owner of the land above described, proposes to transfer the water right therefrom, without loss of priority, to 14.9 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 7, Township 1 North, Range 2 West, W.M., 29.2 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$ and 15.5 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 12, Township 1 North, Range 3 West, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason that said section provides notice is not required on an application for a change in place of use of water.

Mr. Clayton J. Gardner, Watermaster of District No. 1, has filed a statement to the effect that the proposed change in place of use of water may be made without injury to existing rights.


No objections having been filed and it appearing that the proposed change in place of use of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use of water is approved and the water right hereinbefore described as appurtenant to 6.4 acres in SW $\frac{1}{4}$ SW $\frac{1}{4}$, 13.4 acres in SE $\frac{1}{4}$ SW $\frac{1}{4}$, 4.0 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$, 1.9 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 12; 6.7 acres in NE $\frac{1}{4}$ NE $\frac{1}{4}$, 13.8 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$, 9.0 acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$ and 4.4 acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 13, Township 1 North, Range 3 West, W.M., with a date of priority of February 11, 1953, be severed therefrom and simultaneously and without loss of priority transferred to 14.9 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 7, Township 1 North, Range 2 West, W.M., 29.2 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$ and 15.5 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 12, Township 1 North, Range 3 West, W.M.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1974.

It is FURTHER ORDERED that certificate of water right heretofore issued to Remi Coussens and recorded at page 38662, Volume 30, State Record of Water Right Certificates, is canceled and upon receipt of proof satisfactory to the State Engineer of application of water to beneficial use, a certificate of water right shall be issued to Remi Coussens confirming the extent to which the water has been applied beneficially.
