Rights Pursuant to ORS 541.329, Hood ) ORS 541.329 PETITION  
River County, Oregon )

**Authority**

ORS 541.329 establishes the process in which a district may petition the Water Resources Commission for approval and acceptance of a district map identifying the location and use of the water rights within the district.

**Findings of Fact**

1. Pursuant to ORS 541.329,

PARKDALE, OR 97041

submitted a petition requesting approval and acceptance of district maps showing the location and use of water rights within Mt. Hood Irrigation District. The petition was submitted to the Oregon Water Resources Commission on June 30, 1993, and included the required fees.

2. A summary of the rights modified by the petition are displayed in Table 1.
3. Mt. Hood Irrigation District (MHID) petitioned 1003.52 acres of the 1075.90 acres described by the following water rights:

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

4. The rights to be modified are described in Table 2.
5. The location and use of the petitioned water rights are described in Table 3.
6. Table 4 describes the location and use of water rights not modified by the petition. The Department shall issue water right certificates describing the remainder of the water rights not modified by the petition.
7. Water rights not identified or modified by the petition may conflict with petitioned rights. This means that multiple irrigation rights may be located on the same land parcel. Multiple irrigation water rights are not cumulative. Such conflicts, when discovered and identified, may be resolved by the landowner or district at any time. Similarly, such conflicts shall be resolved at the time of any subsequent water right transfer. These conflicts may be resolved by the landowner or district canceling all or a portion of a water right or diminishing all or a portion of a water right from irrigation to supplemental irrigation. Alternatively, in processing a transfer application where multiple irrigation rights exist for the same land parcel, the Department shall designate the right with the oldest priority date as the primary irrigation right and diminish all other rights to supplemental irrigation unless the applicant specifies otherwise.
8. Table 5 describes the location of water rights diminished from irrigation to supplemental irrigation. These are rights that were layered, or in conflict, with petitioned rights as described in Finding of Fact #7. Table 5 also describes the domestic portion of some of these layered rights that are cancelled and no longer in effect.
9. The Department has reviewed the petition and maps submitted by the District. Staff's report on its findings is on file at the Department. Based upon its review and report, the Department finds:
  - a. MHID is a "district" as defined in ORS 541.325(1)
  - b. MHID has met the notice requirements of ORS 541.325(4)
  - c. MHID filed its petition and maps in a timely manner.
  - d. MHID paid the fees required under ORS 536.050(1)(m)
  - e. MHID certified that the notice requirements of ORS 541.325(4) were met.
  - f. The acreage petitioned is within the limits of the eligible water rights and the limits set forth in ORS 541.331(4).
  - g. The petition does not expand the total rights of record of the district.
  - h. The proposed changes result in no injury to existing water rights.
  - i. The content and quality of MHID's petition and maps meet the requirements of ORS 541.331(4).
10. The Department received no complete and timely protests to the Proposed Order approving the petition and maps by any MHID water user affected by the petition within the 60-day prescribed protest period following first publication of newspaper notice.

### **Conclusions of Law**

The petition and maps submitted by Mt. Hood Irrigation District comply with the requirements of ORS 541.325 to ORS 541.333.

**Now, therefore, it is ORDERED:**

1. The Department approves Mt. Hood Irrigation District's petition and maps of water rights.
2. The Department shall issue new confirming water right certificates conforming to the approved petition for:
  - irrigation of 975.22 acres; and
  - supplemental irrigation of 28.30 acres.
3. The Department shall issue a new certificate (termed a remaining right certificate) to describe the rights not modified by the petition.
4. The water rights listed as *diminished* in Table 5 are diminished from irrigation to supplemental irrigation and the Department shall issue new certificates to describe the change in water right status. The water rights listed as *cancelled* in Table 5 are cancelled and no longer valid.
5. The new water right certificates resulting from approval of the petition shall retain the appropriate conditions and limitations upon the rights, seasons of use, priority dates, and rate and duty limitations. The following reference table identifies the new water right certificate numbers resulting from approval of the petition:
