DISTRICT) FOR APPROVAL OF A CHANGE) TRANSFER 5956
IN PLACE OF USE OF WATER)

On June 15, 1987, an application was filed in the office of the Water Resources Director by Clyde Hill for approval of a change in place of use of water from Deschutes River, Wickiip Reservoir, constructed under Permit No. R-1677 and Haystack Reservoir, constructed under Permit No. R-1754, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 51231, Volume 46, State Record of Water Right Certificates, in the name of North Unit Irrigation District, describes a right which includes the use of this water for irrigation of:

0.5 acre in NE 1/4 NE 1/4
0.8 acre in NW 1/4 NE 1/4
Section 31
Township 10 South, Range 14 East, WM

with a date of priority of February 28, 1913. Said lands have a supplemental right under Certificate 51232, from Crooked River, with a date of priority of June 23, 1955.

Water for the said right is diverted, through the North Unit Main Canal.

The applicant herein, owner of the lands above described, proposes to transfer the right therefrom to a certain 1.3 acres in NE 1/4 NE 1/4, Section 32, Township 11 South, Range 13 East, WM.

The certificate recorded at page 51233, Volume 46, State Record of Water Right Certificates, in the name of North Unit Irrigation District, describes a right which includes the use of water from Crooked River for irrigation of

4.8 acres in NW 1/4 NE 1/4
0.2 acre in SW 1/4 NE 1/4
Section 31
Township 10 South, Range 14 East, WM

with a date of priority of September 18, 1968.

The applicant proposes to transfer said right therefrom to a certain 5.0 acres in NE 1/4 NE 1/4, Section 32, Township 11 South, Range 13 East, WM.

Robert F. Main, Jr., Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

The lands involved herein are within the boundaries of the North Unit Irrigation District and the Board of Directors of said District approved the proposed change in place of use of water at a regular meeting.


No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use is approved, without loss of priority.

It is FURTHER ORDERED that the subject water right is hereby severed from the place of use described in Certificates 51231, 51232 and 51233, and shall be beneficially used as authorized by this order on or before October 1, 1989.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of complete application of water to beneficial use on the lands to which the water is transferred hereby, the change in place of use shall be considered perfected, and at a later date certificates of water right shall be issued to North Unit Irrigation District confirming this and other changes within the District, and superseding Certificates 51231, 51232 and 51233.
