O R D E R

On November 22, 1968, Louis M. Matye, Jr. submitted an affidavit that he is the owner of lands claimed to have been irrigated as described in a certificate of registration; that he has abandoned said claim of water right and requests the same be canceled.

That part of the claimed right in question is for the use of not to exceed 10 gallons per minute from a well located N. 86° 50' W. 2915 feet from the southeast corner of Section 24, Township 6 South, Range 2 West, W.M., with a beginning date of 1943, for irrigation of 5.0 acres in the following described tract:

Beginning at a point which is N. 1° 39' E. 1372.14 feet and S. 89° 56' E. 1474.44 feet from the southwest corner of Isaac Headrich D.L.C. 44; thence North 198.71 feet; thence S. 89° 56' E. 1105.25 feet to a point in the county road; thence S. 7° 33' W. along the center of the county road 199.64 feet to a point which is S. 89° 56' E. from the place of beginning; thence N. 89° 56' W. 1079.00 feet to the place of beginning,

being within SE $\frac{1}{4}$  SW $\frac{1}{4}$  and SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 24, Township 6 South, Range 2 West, W.M., and is described in the certificate of registration recorded in Volume 14, page 3245, Ground Water Registration Records.

That part of the claimed right for the use of not to exceed 30 gallons per minute from the described well for irrigation of 5.2 acres in SE $\frac{1}{4}$  SW $\frac{1}{4}$  and 9.8 acres in SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 24, Township 6 South, Range 2 West, W.M., and described in said certificate, is not in question in this proceeding.

NOW, THEREFORE, it is hereby ORDERED that the claim of a water right for the use of not to exceed 10 gallons per minute from a well located N. 86° 50' W. 2915 feet from the southeast corner of Section 24, Township 6 South, Range 2 West, W.M., with a beginning date of 1943, for irrigation of 1.8 acres in SE $\frac{1}{4}$  SW $\frac{1}{4}$  and 3.2 acres in SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 24, Township 6 South, Range 2 West, W.M., is canceled.
