On December 13, 1939, the Squaw Creek Irrigation District filed an application for the approval of a change in place of use of water within the boundaries of said district.

By an order dated February 23, 1934, the State Engineer approved an application of the Squaw Creek Irrigation District transferring certain water rights to, among other lands, the following:

It is FURTHER ORDERED that complete application of water to beneficial use on said lands shall be made on or before October 1, 1941, or such further time as may be extended by the State Engineer for good cause shown.

It is FURTHER ORDERED that upon receipt of proof satisfactory to the State Engineer of complete application of water to beneficial use upon the lands to which the water rights hereby are transferred a certificate of water right shall be issued to the Squaw Creek Irrigation District and that the certificates of water right issued by the State Engineer to the Squaw Creek Irrigation Company and covering, among other lands, the lands from which the water rights are being transferred shall be cancelled.

It is FURTHER ORDERED that the Squaw Creek Irrigation District shall file with the State Engineer on or before October 1, 1940, an application as provided by Section 47-712, Oregon Code 1935 Supplement, for transfer of the excess water rights appurtenant to the following-described lands:
