On January 12, 1968, Ellen J. and Odin A. Hollin submitted an affidavit that they are the owners of lands claimed to have been irrigated as described in a certificate of registration; that they have abandoned said claim of water right and requests the same to be canceled.

That part of the claimed right in question is for the use of not to exceed 205 gallons per minute from a well located 370 feet north and 550 feet east from the southwest corner of the Nw. N. Section 19, Township 6 South, Range 2 Nest, W.M., with a beginning date of 1952, for irrigation of 1.7 acres in NH. SW., 0.6 acre in NW. SW., 36.1 acres in SW. SW., 28.2 acres in SW., SW., 0.6 acre in NW. SE., 7.2 acres in SW. SE., Section 18; and 2.2 acres in NW. N.M., Section 19, Township 6 South, Range 2 Nest, W.M.; and 7.1 acres in SE., SE., Section 13; and 1.4 acres in NE., NE., Section 24, Township 6 South, Range 3 West, W.M., and is described in the certificate of registration recorded in Volume 12, page 2715, Ground Water Registration Records.

That part of the claimed right for the use of not to exceed 355 gallons per minute from the described well for irrigation of 3.9 acres in SW4 SW4, 11.8 acres in SZ4 SW4, 5.5 acres in SW4 SE4, Section 18; and 37.8 acres in NW4 NW4, 40.0 acres in NE4 NW4, 10.7 acres in NW4 NE4, 6.5 acres in SW4 NW4, 6.0 acres in SE4 NW4, 0.3 acre in SW4 NE4, Section 19, Township 6 South, Range 2 West, W.M.; and 20.1 acres in NE4 NE4, 5.1 acres in SE4, Section 24, Township 6 South, Range 3 West, W.M., and described in said certificate, is not in question in this proceeding.

NOW, THEREFORE, it is hereby ORDERED that the claim of water right

for the use of not to exceed 205 gallons per minute from a well located 370 feet north and 550 feet east from the southwest corner of the NW, NW, Section 19. Township 6 South, Range 2 West, W.M., with a beginning date of 1952, for irrigation of 1.7 acres in NE, SW, 0.6 acre in NW, SW, 36.1 acres in SW, SW, 28.2 acres in SE, SW, 0.6 acre in NW, SE, 7.2 acres in SW, SE, Section 18; and 2.2 acres in NW, NW, Section 19. Township 6 South, Range 2 West, W.W.; and 7.1 acres in SE, SE, Section 13; and 1.4 acres in NE, NE, Section 24. Township 6 South, Range 3 West, W.M., is canceled.
