# **Findings of Fact**

- 1. Superior Farms, Inc. filed an application to transfer the place of use under Certificate 44905. The Department assigned the application number T-9306.
- 2. Transfer application T-9306 proposes to modify a portion of the right to be transferred is as follows:

- 4. Notice of the application for transfer was published pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notices.
- 5. Water has been used within the last five years according to the terms and conditions of the right and no evidence is available that would demonstrate that the right is subject to forfeiture under ORS 540.610.
- 6. The proposed change would not result in enlargement of the right.
- 7. The proposed change would not result in injury to other water rights.

#### **Conclusions of Law**

The proposed change in place of use in application T-9306 is consistent with the requirements of ORS Chapter 540 and OAR 690-380-5000.

# Now, therefore, it is ORDERED:

- 1. The change in place of use proposed in application T-9306 is approved.
- 2. Water right certificate 44905 is cancelled. A new certificate will be issued to confirm that portion of the right not involved in this transfer.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificate 44905 and any related rights.
- 4. The proposed change shall be completed on or before October 1, 2005.
- 5. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department by October 1, 2006.

- 6. The former place of use shall no longer receive water under the original authorized use of this water right.
- 7. When satisfactory proof of the completed changes is received, a new certificate confirming the rights transferred will be issued.
