Notice of the filing of the application was given by publication setting forth a time and place certain for hearing objections to the proposed change in point of diversion of water, if any there were, namely: at the county courthouse in Medford, Oregon, on August 7, 1969, at 9:30 a.m. The notice was published in the Medford Mail Tribune, a newspaper printed and having general circulation in Jackson County, Oregon, for a period of three weeks in the issues of June 13, 20, and 27, 1969. The date set for hearing in said notice was not less than thirty days after the last publication of the notice.

Mr. David C. Hendrix, Watermaster of District No. 13, has filed a report to the effect that the proposed change in point of diversion of water may be made without injury to existing rights.

Horace W. and Lenore A. Shriver and Mildred Johnson Fosbury, legal owners of the lands involved, have submitted written approval of the change in point of diversion.

No objections having been filed and it appearing that the proposed change in point of diversion of water may be made without injury to existing rights, the application should be approved.

entered May 19, 1964, In the Matter of the Determination of the Relative Rights to the Use of the Waters of Rogue River and its Tributaries, a water right was established in the name of Edna Van Goethem Galinat for the use of the waters of Evans Creek for domestic and stock use and the irrigation of 4.4 acres in NE% SW% and 5.4 acres in NW% SW%, Section 11, Township 35 South, Range 4 West, W.M., with a date of priority of 1896. This right is evidenced by certificate recorded at page 32790, Volume 24, State Record of Water Right Certificates. These lands are irrigated by means of the Williams and Whalen Ditch from a point of diversion located 475 feet north and 860 feet west from the SE corner of Section 6 being within the SE% SE% of Section 6, Township 35 South, Range 3 West, W.M.

The applicants herein, contract purchasers of the lands above described, propose to irrigate these lands by means of a pump from a point of diversion to be located 690 feet south and 1325 feet east from the WK corner of Section 11 being within the NE% SW% of Section 11, Township 35 South, Range 4 West, W.M.
