**ORDER APPROVING A CHANGE IN PLACE OF USE  
IN AN IRRIGATION DISTRICT**

Pursuant to ORS 540.580 (District Transfer of place of use of water within a district) after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8467 submitted by

OCHOCO IRRIGATION DISTRICT

The right to be modified, as evidenced by a portion of Certificate 55861, was perfected under Permit 49824 with a date of priority of SEPTEMBER 2, 1986 The right allows the use of 0.48 CUBIC FOOT PER SECOND OF WATER FROM OCHOCO CREEK AND STORAGE IN OCHOCO RESERVOIR, CONSTRUCTED UNDER PERMIT R-528, tributaries of THE CROOKED RIVER, for INDUSTRIAL USE.

The authorized place of use is located as follows:

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

This is a final order in other than contested case. Pursuant to ORS 536.075 and OAR 137-004-0080 and OAR 690-01-005 you may either petition the Director for reconsideration of this order or petition for judicial review of this order.

As provided in ORS 536.075, this order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the time specified by ORS 183.484(2).

The applicant proposes to change the place of use to:



THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 2001.
2. Use at the former place of use shall no longer be allowed as a part of this water right.
3. Proof to the satisfaction of the Director, that the change approved by this order has been completed must be submitted by OCHOCO IRRIGATION DISTRICT, on or before October 1, 2002.

Certificate 55861 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
