ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6604 submitted by

CROOKED RIVER RANCH
P.O. BOX 879
CROOKED RIVER RANCH, OREGON 97760.

The right to be modified, as evidenced by Certificate 48452, was perfected under Permit G-2280 with a date of priority of JANUARY 24, 1963. The right allows the use of WELL 2, a tributary of CROOKED RIVER BASIN, for IRRIGATION 91.1 ACRES. The right is limited to 1.14 cubic foot per second, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:


The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1992.
2. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
3. The former place of use shall no longer be irrigated as part of this water right.

Certificate 48452 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
