## ORDER APPROVING A CHANGE IN POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves TRANSFER 6304 submitted by

H.T. BURNS, INC. 730 W. TAMARACK AVE. HERMISTON, OR 97838

to use the waters of THREE WELLS in the COLD SPRINGS WASH BASIN for the purpose of IRRIGATING 11.2 ACRES.

The right to be transferred, as evidenced by certificate 61659, was perfected under Permit G-9307 with a date of priority of JANUARY 29, 1981. The right is limited to 0.14 cubic foot per second, or its equivalent in case of rotation, measured at the wells.

The new points of appropriation are located as follows:

NE 1/4 SW 1/4, NW 1/4 SE 1/4, SW 1/4 NW 1/4, SECTION 10, T 4 N, R 29 E, W.M.; WELL 1 - 1460 FEET NORTH AND 2240 FEET EAST FROM THE SW CORNER OF SECTION 10, WELL 2 - 1520 FEET NORTH AND 50 FEET EAST FROM THE S 1/4 CORNER OF SECTION 10, WELL 3 - 1200 FEET NORTH AND 1420 FEET WEST FROM THE C 1/4 CORNER OF SECTION 10.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use is as follows:

NE 1/4 SE 1/4 11.2 ACRES SECTION 10
TOWNSHIP 4 NORTH, RANGE 29 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1991.
- 2. The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water available from the original point of appropriation, SW 1/4 SW 1/4, SECTION 11, T 4 N, R 29 E, W.M.; 40 FEET NORTH AND 80 FEET EAST FROM THE SW CORNER OF SECTION 11,
- 3. The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Each well at the new point of appropriation shall include an access port.
- 5. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 61659 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
