ORDER

On May 28, 1974, Mike B. Porter submitted an affidavit that he is the owner of lands claimed to have been irrigated as described in certificate of registration recorded at page GR-3245, Volume 14, Ground Water Registration Record; that he has abandoned said claim of water right and request the same be canceled.

That part of the claimed right in question is for the use of not to exceed 10 gallons of water per minute from a well located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 24, Township 6 South, Range 2 West, W.M., for the irrigation of 1.8 acres within the SE $\frac{1}{4}$ SW $\frac{1}{4}$ and 3.2 acres within the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 24, Township 6 South, Range 2 West, W.M., described as follows:

Beginning at a point which is 1,372.14 feet North 1 degree 39' east and 1,474.44 feet South 89 degrees 56' east and 807.51 feet North from the Southwest corner of the Issac Headrick Donation Land Claim No. 44 in Township 6 South, Range 2 West, of the Willamette Meridian in Marion County, Oregon; thence South 194.7 feet; thence South 89 degrees 56' East, a distance of 1,105.25 feet to a point in the County Road; thence North 7 degrees 33' East, along the center of said County Road, a distance of 196.30 feet; thence North 89 degrees 56' West, a distance of 1,130.95 feet to the place of beginning.


That part of the claimed right described in said certificate for the appropriation of not to exceed 20 gallons of water per minute from a well located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 24, Township 6 South, Range 2 West, W.M., for the irrigation of 3.4 acres within the SE $\frac{1}{4}$ SW $\frac{1}{4}$ and 6.6 acres within the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 24, Township 6 South, Range 2 West, W.M., is not in question in this proceeding.

NOW, THEREFORE, it is hereby ORDERED that the claim of a water right for the use of not to exceed 10 gallons of water per minute from a well, being within the SW $\frac{1}{4}$ SW $\frac{1}{4}$, for the irrigation of 1.8 acres within the SE $\frac{1}{4}$ SW $\frac{1}{4}$ and 3.2 acres within the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 24, Township 6 South, Range 2 West, W.M., described as follows:

Beginning at a point which is 1,372.14 feet north 1 degree 39' east and 1,474.44 feet South 89 degrees 56' east and 807.51 feet north from the Southwest corner of the Issac Headrick Donation Land Claim No. 44 in Township 6 South, Range 2 West of the Willamette Meridian in Marion County, Oregon; thence South 194.70 feet; thence South 89 degrees 56' East, a distance of 1,105.25 feet to a point in the County Road; thence north 7 degrees 33' East, along the center of said County Road, a distance of 196.30 feet; thence north 89 degrees 56' West, a distance of 1,130.95 feet to the place of beginning.
