On July 17, 1984, an application was filed in the office of the Water Resources Director by Wilbur Vanderbeck for approval of a change in place of use of water from Butte Creek, pursuant to the provisions of ORS 540.510 to 540.530.

Pursuant to the provisions of ORS 537.250, proof has been made to the satisfaction of the Water Resources Director that a right has been perfected under the terms of Transfer 5069 in the names of Wilbur and Darline Vanderbeck for the use of not to exceed 0.15 cubic foot per second from Butte Creek for irrigation of 2.5 acres in SE 1/4 NE 1/4, Section 8; 10.0 acres in SW 1/4 NW 1/4 and 5.0 acres in NW 1/4 SW 1/4, Section 9, all as projected within Jeremiah Jack Donation Land Claim 41, Township 6 South, Range 1 East, WM, with a date of priority of August 2, 1938.

Water for the said right is diverted from a point located within the NE 1/4 SE 1/4 of Section 8, Township 6 South, Range 1 East, WM.

The applicant herein, owner of the lands above described, proposes to transfer the right therefrom to a certain 4.5 acres in SE 1/4 NE 1/4 and 6.5 acres in NE 1/4 SE 1/4, Section 8; and 6.5 acres in NW 1/4 SW 1/4, Section 9, Township 6 South, Range 1 East, WM.

Clifton R. King, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use is approved, without loss of priority.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1986.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to Wilbur and Darline Vanderbeck.
