IN THE MATTER OF THE CANCELATION OF
CERTAIN PERMITS TO APPROPRIATE WATER
UNDER THE PROVISIONS OF ORS 537.260

ORDER

At this time, it appears that the time within which the appropriations under the following water right permits should have been perfected has expired, and that the owners of such permits have failed within the period of three months thereafter to submit proof of the completion of such appropriations as required by ORS 537.260, and that notices have been addressed to each of the owners of said permits by certified mail in accordance with the provisions of ORS 537.260 and 174.150, and that the owners of said permits have failed or refused to submit proof of the completion of the appropriations under their respective permits, although the sixty day time limits allowed in such notices have elapsed.

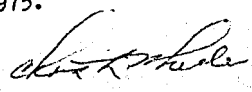
