ORDER

H. L. Wahl and Viola Wahl have submitted a sworn statement that they are the legal owners of a certain water right and the real property to which the water right is appurtenant; that they have abandoned any and all interest to a portion of the said water right and request the same to be canceled.

The water right in question is a part of that evidenced by the certificate recorded at Volume 19, page 27428, State Record of Water Rights Certificates, and is for the appropriation of not to exceed 0.09 cubic foot per second of water, with a date of priority of January 14, 1953 and 0.01 cubic foot per second of water, with a date of priority of March 4, 1952, from well No. 1 on unit No. 1 for irrigation of 0.5 acre in the southeast corner of the SW/4 NE% and 7.3 acres in the south and easterly part of the SE% NE%, Section 27, Township 27 South, Range 17 East, W.M.

That part of the water right evidenced by said certificate for the appropriation of not to exceed 2.66 cubic feet per second of water from well No. 1 on unit No. 1, with a date of priority of March 4, 1952, for the irrigation of 213.2 acres as follows:

40.0 acres NW¼ NE¼
37.4 acres SW¼ NE¼
26.8 acres SE¼ NE¼
24.6 acres NE¼ NW¼
10.0 acres SW¼ NW¼
35.4 acres SE¼ NW¼,

Section 27, Township 27 South, Range 17 East, W.M.,

is not in question.

ORS 540.621 provides that: "Whenever the owner of a perfected and developed water right certifies under oath to the State Engineer that the water right has been abanound by him and that he desires cancelation thereof, the State Engineer shall enter an order canceling the water right".

NOW, THEREFORE, it hereby is ORDERED that the water right for the use of 0.09 cubic foot per second of water, with a date of priority of January 14, 1953 and 0.01 cubic foot per second, with a date of priority of March 4, 1952, from well No. 1 on unit No. 1 for irrigation of 0.5 acre in the southeast corner of the SW% NE% and 7.3 acres in the south and easterly part of the SE% NE%, Section 27, Township 27 South, Range 17 East, W.M., is canceled.

It is FURTHER ORDERED that the certificate of water right recorded at Volume 19, page 27428, State Record of Water Rights Certificates, is canceled and lieu thereof a new certificate be issued to H. L. Wahl and Viola Wahl covering that part of the water right not in question which is for the appropriation of not to exceed 2.66 cubic feet per second of water from well No. 1 on unit No. 1, with a date of priority of March 4, 1952, for irrigation of the following lands:

39.0 acres NEW NEW

40.0 acres NW/4 NE/4

37.4 acres SW4 NE%

26.8 acres SEM NEM

24.6 acres NE% NW%

10.0 acres SW4 NW4 35.4 acres SE4 NW4.
