ORDER

On August 20, 1969, Robert A. and Eunice B. Fiedler submitted an affidavit that they are the owners of lands claimed to have been irrigated as described in a certificate of registration; that they have abandoned said claim of water right and request the same be canceled.

That part of the claimed right in question is for the use of not to exceed 167 gallons per minute from well No. 1 located 990 feet east and 1000 feet north from the northwest corner of Herron DLC 48, Section 7, Township 7 South, Range 2 West, W.M., with a beginning date of June 18, 1955, for irrigation of 6.0 acres in NEW NEW, 1.8 acres in SEW NEW, Section 7; and 5.4 acres in NWA NWA, 1.5 acres in SWM NWA, Section 8, Township 7 South, Range 2 West, W.M., and is described in the certificate of registration recorded in Volume 4, page 706, Ground Water Registration Records.

That part of the claimed right for the use of not to exceed 13 gallons per minute from the described well for irrigation of 1.0 acre in SEM NEW, Section 7, Township 7 South, Range 2 West, W.M., being within the following described tract:

Beginning on the south line of Satter Drive, at a point which is N. 89° 50' E., 600.88 feet; S. 0° 06' E., 822.60 feet; S. 89° 58' E., 130.00 feet; and S. 89° 21' E., 131.00 feet from the northeast corner of Lewis Savage DLC 40; thence S. 89° 21' E. along the south line of Satter Drive 179.00 feet; thence N. 0° 39' E. 245.80 feet; thence N. 89° 21' W. 179.00 feet; thence S. 0° 39' W. 245.80 feet to the place of beginning.

and described in said certificate, is not in question in this proceeding.

NOW, THEREFORE, it is hereby ORDERED that the claim of water right for the use of not to exceed 167 gallons per minute from a well located 990 feet east and 1000 feet north from the northwest corner of Herron DLC 48, Section 7, Township 7 South, Range 2 West, W.M., with a beginning date of June 18, 1955, for irrigation of 6.0 acres in NE% NE%, 1.8 acres in SEM NE%, Section 7; and 3.4 acres in NW% NW%, 1.5 acres in SW% NW%, Section 8, Township 7 South, Range 2 West, W.M., is canceled.
