ORDER APPROVING AN ADDITIONAL POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6845 submitted by

THEODORE A. HENDRICKSON
ROUTE 2, BOX 29
ECHO, OREGON 97826.

The right to be modified, as evidenced by Certificate 72231, was perfected under Permit G-6044 with a date of priority of FEBRUARY 21, 1974. The right allows the use of A WELL, in the UMATILLA RIVER BASIN, for PRIMARY IRRIGATION OF 26.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 64.6 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.62 CUBIC FOOT PER SECOND, if available at the original well; NW $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 10, T 2 N, R 30 E, WM; 975 FEET SOUTH AND 750 FEET EAST FROM THE N $\frac{1}{4}$ CORNER, SECTION 10, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 ACRE-FEET per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This right is limited to any deficiency in the available supply for any prior right existing for the same land.

The user shall install and maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The applicant proposes to add an additional point of diversion to:

NW $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 10, T 2 N, R 30 E, WM; 2050 FEET NORTH AND 250 FEET EAST FROM THE CENTER, SECTION 10.


The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1998.
2. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.
3. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 72231 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
