THESE TEMPORARY CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The changes are temporary. The changes shall be effective upon issuance of this order.
2. The former place of use shall not be irrigated as part of this water right during the 2003 irrigation season.
3. The use shall revert to the authorized place of use at the end of the 2003 irrigation season.
4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
5. The use of the remaining water rights described by Certificates 2690, 2687, 2696, 25902, 25903, 25776 and 32592 shall continue to be in accordance with the terms and conditions of Certificates 2690, 2687, 2696, 25902, 25903, 25776 and 32592.
