### ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6891 submitted by

IVERSON BROTHERS
33739 SOUTH MERIDIAN ROAD
WOODBURN, OREGON 97071.

The first right to be modified, as evidenced by a Certificate 29408, was perfected under Permit G-1554 with a date of priority of MARCH 9, 1960. The right allows the use of A WELL (WELL#14), in the SANTIAM RIVER BASIN, for IRRIGATION OF 78.3 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.89 cubic foot per second, if available at the original well; WELL #14 - SW% NE%, AS PROJECTED WITHIN MILLER DLC 66, SECTION 3, T 10 S, R 3 W, W.M.; 1400 FEET SOUTH AND 2100 FEET WEST FROM THE NE CORNER OF SECTION 3, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The second right to be modified, as evidenced by a Certificate 397¶9, was perfected under Permit G-3999 with a date of priority of FEBRUARY 19, 1968. The right allows the use of A WELL (WELL#16), in the SANTIAM RIVER BASIN, for SUPPLEMENTAL IRRIGATION OF 78.3 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.55 cubic foot per second, if available at the original well; WELL #16 - SW¼ SE¼, SECTION 34, T 9 S, R 3 W, W.M.; 1270 FEET NORTH AND 2115 FEET WEST FROM THE NE CORNER OF SECTION 34, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

WELL #16 - SW% SE%, SECTION 34, T 9 S, R 3 W, W.M.; 1270 FEET NORTH AND 2115 FEET WEST FROM THE SE CORNER OF SECTION 34.

#### PERMIT G-3999

WELL #14 - SW% NE%, AS PROJECTED WITHIN MILLER DLC 66, SECTION 3, T 10 S, R 3 W, W.M.; 1400 FEET SOUTH AND 2100 FEET WEST FROM THE NE CORNER OF SECTION 3.

### PERMIT G-1554 AND G-3999

WELL #19 - NW% NE%, AS PROJECTED WITHIN MILLER DLC 66, SECTION 3, T 10 S, R 3 W, W.M.; 840 FEET SOUTH AND 2220 FEET WEST FROM THE NE CORNER OF SECTION 3.

THIS CHANGE TO THESE EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1999.
- 2. The quantity of water diverted at the new points of appropriation (wells), together with the quantity diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available from the original points of appropriation.
- 3. When required by the Department the water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original points of appropriation.

Certificates 29408 and 39799 are cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
