On July 2, 1982, pursuant to ORS 540.631, Samuel Bartow, Jr., Ellen W. Bartow, Clyde W. Purcell, and Bonnie Buchanan were notified as the owners of record of certain real property within Section 19 of Township 15 South, Range 16 East, WM, Crook County, Oregon, of the proposed cancellation of a certain water right appurtenant to said property.

The water right in question is for the appropriation of not to exceed 2.55 cubic feet per second of water from Crooked River under a priority date of February 28, 1909, for irrigation of a certain 30.0 acres in NE 1/4 NE 1/4, 16.1 acres in NW 1/4 NE 1/4, 24.2 acres in SW 1/4 NE 1/4, 40.0 acres in SE 1/4 NE 1/4, 3.4 acres in SE 1/4 SW 1/4, 20.0 acres in NE 1/4 SE 1/4, 31.0 acres in NW 1/4 SE 1/4, 29.1 acres in SW 1/4 SE 1/4, and 10.0 acres in SE 1/4 SE 1/4 of Section 19, Township 15 South, Range 16 East, WM, being a portion of the right described by the certificate issued to Grant Mays and Harold Baldwin and recorded at page 2394, Volume 3, State Record of Water Right Certificates. The said lands are further identified as being east of the highway which runs between the City of Prineville and the Prineville Reservoir Dam.

ORS 540.641(1) provides: "If the legal owner or the occupant receiving notice as provided in ORS 540.631 fails to protest cancellation of the water right within the 60-day period prescribed in the notice, the Water Resources Director may enter an order canceling the water right."

No protest has been filed against the proposed cancellation of the water right in question.

NOW, THEREFORE, it is ORDERED that the water right in question, being a portion of the right described by the certificate recorded at page 2394, Volume 3, State Record of Water Right Certificates, be and the same hereby is canceled.

It is FURTHER ORDERED that the said certificate of water right is canceled, and in lieu thereof a new certificate be issued to describe the balance of the water right NOT involved in this proceeding.
