ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 8484 submitted by

JEFF CAMPBELL 113 CABIN LAKE ROAD FORT ROCK, OREGON 97735

The first right to be modified, as evidenced by a PORTION of Certificate 46977, was perfected under Permit G-5762, with a date of priority of NOVEMBER 30, 1973. The right allows the use of CAMPBELL WELL 1, in the CHRISTMAS LAKE BASIN, for IRRIGATION OF 42.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.53 cubic foot per second, if available at the original well; NW% SW%, SECTION 16, T 25 S, R 14 E, W.M.; 2660 FEET SOUTH AND 1320 FEET EAST FROM THE NW CORNER OF SECTION 16, or its equivalent in case of rotation, measured at the well.

The second right to be modified, as evidenced by a PORTION of Certificate 46980, was perfected under Permit G-6812, with a date of priority of MAY 6, 1976. The right allows the use of CAMPBELL WELL 1, in the CHRISTMAS LAKE BASIN, for IRRIGATION OF 16.0 ACRES. The amount of water to which this right is entitled

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

is limited to an amount actually beneficially used and shall not exceed 0.20 cubic foot per second, if available at the original well; NW% SW%, SECTION 16, T 25 S, R 14 E, W.M.; 2660 FEET SOUTH AND 1320 FEET EAST FROM THE NW CORNER OF SECTION 16, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

THIS TEMPORARY CHANGE TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The change is temporary. The change shall be effective upon issuance of this order.
- 2. The former places of use shall not be irrigated as part of these water rights during the 2000 irrigation season.
- 3. The use shall revert to the authorized places of use at the end of the 2000 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- 5. The use of the remaining water rights described by Certificates 46977 and 46980 shall continue to be in accordance with the terms and conditions of Certificates 46977 and 46980.
