Findings of Fact

- The Bagley Ditch Corporation, for several property owners (listed below with each water right description), filed an application to transfer the point of diversion, under multiple Certificates. The Department assigned the application number T-9733. On August 15, 2005 Dennis Glender, agent for the applicants, amended the application, to move only 0.78 acre of the right under Certificate 3654 to a new place of use. A revised map reflecting the change was submitted September 1, 2005.

- 91. Notice of the application for transfer was published pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice. However, the Oregon Department of Fish and Wildlife did submit correspondence requesting that a condition requiring installation of proper fish screens be included in the transfer order. Newspaper notice of the Preliminary Determination was published in the Lake County Examiner October 6, 13 and 20, 2005. No protests were filed.
- 92. Water has been used within the last five years according to the terms and conditions of the rights and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 93. A diversion structure and ditch sufficient to use the full amount of water allowed under the existing rights are present.
- 94. The proposed changes would not result in enlargement of the right.
- 95. The proposed changes would not result in injury to other water rights.
- 96. Pursuant to OAR 690-380-4010(5), upon receipt of the draft preliminary determination, the agent for the applicant submitted a response in an e-mail message dated August 24, 2005, indicating corrections to information reported in Finding 90 about the lands on which the proposed places of use are appurtenant. The corrections included deleting reference to 0.13 acres in current tax lot 33 18 24CA-2000 owned by Lora B. Carlon, and changing the ownership information for current tax lot 33 18 24C-1301 from Murphy Ranch to Robert and Lynda Lown. Those corrections to the draft have been integrated into this document.

Redescription of Lands

97. Lands irrigated or susceptible to irrigation from the Chewaucan River and tributaries were to have been investigated and mapped by the State Engineer and his assistant beginning December 16, 1912, according to published notice. However, the decree of the Circuit

Court of the State of Oregon for Lake County, of record at Salem, in the Order Record of the Water Resources Director dated December 2, 1916 entered at Volume 5, Pages 3-4, Section III states that the data were gathered and surveys on which the maps were based had been made prior to December 16, 1912. Because there was no investigation of the lands pursuant to the notice or thereafter, the decree concludes that the maps are not to be considered correct in describing placement of the water rights.

- 98. In several certificates the estimated number of acres and described locations are not consistent with how the Public Land Survey boundaries overlay property lots, particularly within the town of Paisley Oregon. These instances are noted herein, and the locations where the rights have always been exercised are proposed to be redescribed based on investigations made by the Water Resources Department in the years 1980-1989 and 2005, and to be consistent with the Public Land Survey and the survey of the Town of Paisley.
- 99. Water right claims appurtenant to properties within the town of Paisley submitted by landowners as "proof" forms, listing approximate acreage per section quarter-quarter, were not subsequently investigated to confirm the accuracy of the submitted proofs, or the map previously prepared by the State Engineer. The State Engineer's map of Paisley lots did not list acreage or ownership of properties, but stated that the map was drafted at a scale of 1 inch = 200 feet.
- 100. **Certificate 3599:** According to how the Public Land Survey subdivisions overlie the surveyed lots of the town of Paisley, Oregon, Lot 3 in Block L, South Addition and Lot 8 in Second South Addition are partly in the NE ¼ of the SW ¼ and mostly in the SE ¼ of the SW ¼ of Section 24, T33S, R18E, W.M.
 - a) Lake County Tax Assessor Map 33-18-24CD shows that Lot 3 in Block L, South Addition, and Lot 8 in Second South Addition to the Town of Paisley comprise the west half of current tax lot 200.

- 105. **Certificate 3662** was issued based on proof Volume 2—Number 103 claiming 0.7 acre in the NE ¹/₄ of the SW ¹/₄ of Section 24.
 - a) Deed record Vol. 44, page 255 lists sale of Lot 5 in the South Addition of Paisley to E.O. Lamb on May 23, 1912, but indicates a correction in the description in Vol. 47, p. 589, recorded September 1, 1914. The corrected description of the property takes in the majority of Lot 5 and Lot 6 in Block "L" of Paisley.
 - b) Based how the Public Land Survey subdivisions overlie the surveyed lots of the town of Paisley, Oregon, this property is located partly within the NE½ SW¼ and partly within

the SE ¼ SW ¼ of Section 24, Township 33 South, Range 18 East. This location is also consistent with the original adjudication map prepared by the State Engineer, leading the Department to conclude that the land to which the right has always been appurtenant should be redescribed as within the NE¼ SW¼ and SE ¼ SW 1/4 of Section 24, Township 33 South, Range 18 East of Willamette Meridian, Lake County, Oregon. It is estimated that approximately 0.06 acre is in the NE ¼ SW ¼ and 0.64 acre is in the SE ¼ SW¼.

- c) Lake County Tax Assessor Map 33-18-24CD shows the western part of tax lots 100 and 102 roughly coinciding with this area.
- d) The following table describes the difference between the place of use description in certificate 3662 and a proposed redescription of the place of use based on the above findings:

106. **Certificate 3686:** Based on the dimensions given in Proof 143 and how the Public Land Survey subdivisions overlie the surveyed lots of the town of Paisley, Oregon, the place of use under Certificate 3686 appears to include some land in the SW SW of Section 24 T33S, R18E as well as land in the NW SW and NE SW.

Certificate 3686 is proposed to be re-described as follows:

- 107. Certificate 3691: The clear location of the lands shown in the map submitted with Proof 151 matches current tax lot 33 14 24D-800 owned by School District #11 and appears to be the location to which the water right under Certificate 3691 has always been appurtenant. Based on how the Public Land Survey subdivisions overlie the surveyed lots of the town of Paisley, Oregon, this property is located within the NW¼ SE¾. The water right should be redescribed as 1.8 acres in the NW¼ SE¾, Section 24, Township 33 South, Range 18 East, W.M.
- 108. Certificate 3696: Certificate 3696 allows 1.0 acre of irrigation, however, Proof 157 for the right claims that the lot in Paisley to which the right is appurtenant is 168½' x 153'. These dimensions exactly match the meets and bounds description of the relevant property (Tax Lot 33 18 24CA-4500), which equals 0.59 acre. The right has always been limited to 0.59 acre, and should be redescribed accordingly. Current landowners Kathleen A. McAuliffe, Laura M. Davila and Rosanna J. Bagley have submitted affidavits consenting to redescription of the water right as 0.59 acre.
- 109. **Certificate 3699:** 40 acres of water right in the NE¹/₄ NE¹/₄ of Section 6, Township 34 South, Range 19 East, W.M. was claimed on the Proof 98 map for this right, though it was not listed on the tabulation in the proof, decree or Certificate 3699. This is a scrivener's error, because the total number of acres claimed includes 40 more acres than are listed. The confirming certificate for the right will correct the listing by including the 40 acres shown on the map in the NE¹/₄ NE¹/₄ of Section 6.

Partial Cancellation of Water Rights

- 110. ORS 540.621 provides that when the owner of a perfected and developed water right desires cancellation of the portion of the water right that has been abandoned, the Department may issue an order canceling the abandoned portion of the water right. Effective upon the date of the order, the water which was the subject of use under the water right shall revert to the public and become again subject to appropriation by other users.
- 111. The applicants have submitted affidavits authorizing cancellation of the portions of the rights listed below:

Conclusions of Law:

The changes in point of diversion and place of use proposed in application T-9733 are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. The changes in point of diversion and place of use proposed in application T-9733 are approved.
- 2. Water right certificates 2818, 2870, 3233, 2599, 3604, 3605, 3622, 3625, 3629, 3630, 3631, 3635, 3636, 3638, 3639, 3641, 3642, 3647, 3653, 3654, 3655, 3656, 3659, 3662, 3666, 3669, 3671, 3672, 3673, 3675, 3679, 3683, 3685, 3686, 3687, ,3691, 3695, 3696, 3697, 3698, 3699, 72364, and 80631 are cancelled. New certificates 81703-81719 will be issued describing the portions of the rights not involved in this transfer.
- The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in the certificates described above and any related decrees.
- 4. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2007.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 5. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.
- 6. The former place of use of the transferred water under certificate 3654 shall no longer be irrigated as part of that water right.
- 7. Prior to diverting water, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

- 8. The water user shall install and maintain a fish screen or fish by-pass device, as appropriate, at the new point of diversion. The type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and Wildlife prior to beginning of construction, and shall be installed under the supervision of the Department of Fish and Wildlife. The water user may participate in the Department of Fish and Wildlife's cost-sharing program for installation of screening and by-pass devices in accordance with ORS 540.525.
- 9. So as to clarify the record, upon perfection of the change in point of diversion, the certificates issued for the rights originally perfected under Certificates 3599, 3605, 3625, 3647, 3653, 3662, 3686, 3691, 3696 and 3699 confirming the change shall redescribe the places of use as proposed in Findings 100-109.
- 10. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
