### Authority

ORS 540.570 to 540.580 establishes the process in which a district may submit a request to transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

### Applicant

### **Findings of Fact**

- 1. On June 10, 2009, Three Sisters Irrigation District (TSID) filed a district transfer application to permanently change the place of use under Certificate 74135 and Water Use Permits G-11378 and S-29312. The Department assigned the application number T-10900.
- 2. On July 1, 2009, the application was amended to also include modifications to Certificate 74142.
- 3. On September 21, 2005, Certificate 74142 was superseded by Certificate 81475. Certificate 81475 was superseded by Certificate 86162 on March 31, 2010.
- 4. Notice of the application for transfer was published on June 16, 2009, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.
- 5. Three Sisters Irrigation District was formerly named Squaw Creek Irrigation District.
- The portion of the primary right to be transferred is as follows:

Certificate: 74135 in the name of SQUAW CREEK IRRIGATION DISTRICT

Use: IRRIGATION of 39.70 acres Priority Dates: 1895 and 1904

Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

Source: Wychus Creek (formerly named Squaw Creek), a tributary of the Deschutes River

Priority Date: December 26, 1976 Rate: 0.014 cubic foot per second (cfs)

Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH (1/80) of one cfs or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right is also limited to any deficiency in the available supply of any prior right existing for the same land.

- 10. The appurtenant supplemental water use permits (G-11378 and S-29312) will be moved concurrently with the layered primary water right (Certificate 74135) as described above.
- 11. The district permanent transfer application satisfies the criteria of OAR 690-385-4000 contains the information required under OAR 690-385-2000 and includes maps meeting the requirements of OAR 690-385-2200.
- 12. The water rights and water use permits are subject to transfer as defined in OAR 690-385-0100(17).
- 13. The proposed change in places of use will not result in enlargement of the rights or water use permits.
- 14. The proposed change in places of use will not result in injury to other water rights.

#### Conclusions of Law

The changes in place of use as proposed in Transfer Application T-10900 satisfy the requirements of ORS 540.574(3) and 540.580.

## Now, therefore, it is ORDERED:

- 1. The proposed changes in place of use to the water rights evidenced by Certificates 74135 and 86162 and Water Use Permits G-11378 and S-29312 are approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 74135 and 86162, Water Use Permits G-11378 and S-29312 and any related decree.
- 3. The former place of use shall no longer be irrigated as part of these water rights or water use permits.
- 4. The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.
- 5. The approved changes shall be completed and full beneficial use of the water shall be made on or before October 1, 2012.
- 6. A Claim of Beneficial Use (CBU) shall be submitted by the applicant to the Department by October 1, 2013.
- 7. Water right Certificate 74135 and Water Use Permits G-11378 and S-29312 are modified. The Department will issue a superseding certificate describing the rights when it determines it is necessary for record keeping.
- 8. Water right Certificate 86162 is cancelled. The Department will issue Certificate 87239 describing that portion of the water right NOT modified by this transfer.
