ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 8502 submitted by

J. FRANK SCHMIDT & SON CO. P.O. BOX 189 BORING, OREGON 97009

The right to be modified, as evidenced by a PORTION of Certificate 50656, was perfected under Permit G-6086, with a date of priority of NOVEMBER 20, 1975. The right allows the use of A WELL, in the PUDDING RIVER BASIN, for IRRIGATION OF 15.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.19 cubic foot per second, if available at the original well; SE% SW%, SECTION 19, T 4 S, R 1 E, W.M.; 980 FEET NORTH AND 1580 FEET EAST FROM THE NW CORNER OF FISH DLC 40, or its equivalent in case of rotation, measured at the well.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SE¼ NE¼ 0.3 ACRE NE¼ SE¼ 14.7 ACRES SECTION 19

TOWNSHIP 4 SOUTH, RANGE 1 EAST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to TEMPORARILY change the place of use to:

NE¼ SE¼ 4.8 ACRES NW¼ SE¼ 1.9 ACRES SW¼ SE¼ 2.1 ACRES SE¼ SE¼ 6.2 ACRES SECTION 18

TOWNSHIP 4 SOUTH, RANGE 1 EAST, W.M.

THIS TEMPORARY CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The change is temporary. The change shall be effective upon issuance of this order.
- 2. The former place of use shall not be irrigated as part of this water right during the 2000 irrigation season.

- 3. The use shall revert to the authorized place of use at the end of the 2000 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- 5. The use of the remaining water right described by Certificate 50656 shall continue to be in accordance with the terms and conditions of Certificate 50656.
