**ORDER APPROVING A CHANGE IN PLACE OF USE**

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6458 submitted by

JAMES E. STEARNS, JR.  
802 GREEN VALLEY ROAD  
OAKLAND, OREGON 97462.

The right to be modified, as evidenced by a PORTION of Certificate 50896, was perfected under Permit 5847 with a date of priority of APRIL 20 1923. The right allows the use of CALAPOOYA CREEK, a tributary of UMPQUA RIVER, for IRRIGATION 0.5 ACRE. This right is limited to 0.006 cubic foot per second, if available at the authorized point of diversion: SE $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within REED DLC 58, SECTION 5, T. 25 S., R. 5 W., W.M.; 820 FEET SOUTH AND 3080 FEET EAST FROM THE NW CORNER OF REED DLC 58, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent).

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SW $\frac{1}{4}$  SE $\frac{1}{4}$  0.5 ACRE  
as projected within REED DLC 58  
SECTION 5  
TOWNSHIP 25 SOUTH, RANGE 5 WEST, W.M.

The applicant proposes to change the place of use to:

NW $\frac{1}{4}$  SE $\frac{1}{4}$  0.5 ACRE  
as projected within REED DLC 58  
SECTION 5  
TOWNSHIP 25 SOUTH, RANGE 5 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.



THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1992.
2. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 50896 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
