Findings of Fact

Background

- On July 16, 1992, J.R. Simplot filed a transfer application to change the place of use and points of diversion under Certificates 52677, 52678, 52679, 52680, 67322, 68761, 68762 and 68763. The Department assigned the application number T-6783.

31. Notice of the application for transfer was published on July 21, 1992, pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice. However, the Oregon Department of Fish and Wildlife did request inclusion of a condition requiring installation of proper fish screens.

Transfer Review Criteria (OAR 690-380-4010)

- 32. Water was used within the five-year period prior to submittal of the transfer application according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 33. Pumps, pipeline, and sprinkler systems sufficient to use the full amount of water allowed under the existing rights are present.
- 34. Further review of Transfer Application T-6783 revealed that a portion of the "FROM" lands changed ownership and a water right conveyance agreement was recorded agreeing to allow Simplot, Inc. to transfer off the rights. On November 8, 2007, the Department received a copy of the water right conveyance agreement that authorizes the applicant to transfer off the rights as described above.
- 35. The reach of the river between the existing authorized points of diversion and the proposed new points of diversion is within the reach of the Umatilla River described in instream water right Certificate 59837. Stream flows within the reach are frequently below the levels allocated under the instream water right. The proposed upstream points of diversion changes will result in a reduction of flows in the reach.
- 36. Instream water right certificate 59837, established pursuant to ORS 537.346 at the request of the Oregon Department of Fish and Wildlife, is for flows to be maintained in the Umatilla River from McKay Creek (Section 8, T 2 N, R 32 E, W.M.) to the mouth of Umatilla River at River Mile 0.0 (Section 18, T 5 N, R 28 E, W.M.). The date of priority of the right is November 3, 1983.

- 37. Certificate 59837 is deficient annually during a portion of the irrigation season. The instream right is junior to the rights involved in Transfer Application T-6783(proposing to change the points of diversion and place of use) and would further reduce flows in a portion of the designated reach of the instream water right.
- 38. No water rights, other than the instream water right, have been identified as having authorized diversion within the affected reach of the Umatilla River.
- 39. As described in Findings of Fact #8, #12, #16, #20 and #37, the proposed upstream point of diversion changes would result in injury to instream water right Certificate 59837.
- 40. The proposed changes in place of use would not result in injury to other water rights.
- 41. The proposed changes would not result in enlargement of the rights.
- 42. Due to the potential for injury to instream water right Certificate 59837, the Department mailed a *draft* Preliminary Determination proposing to **deny** Transfer Application T-6783, to the applicant on December 20, 2006. The cover letter that accompanied the *draft* Preliminary Determination set forth a deadline of January 22, 2007, for the applicant to respond. The applicant requested the Department proceed with issuance of a Preliminary Determination, pursue consent to injury to the instream water right as outlined in ORS 540.530 and OAR 690-380-5050 and requested the Department seek a recommendation from the agency that requested the instream water right. Additionally, at this time the applicant provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 43. On January 3, 2008, the Department issued a Preliminary Determination consistent with the *draft* Preliminary Determination. Concurrent with the issuance of the Preliminary Determination, the Department requested that the Oregon Department of Fish and Wildlife (ODFW) recommend whether the Water Resources Department should consent to the injury of the instream water right.
- 44. On February 17, 2009, ODFW recommended that the Department consent to the injury of instream water right Certificate 59837 because the proposed changes would result in a net benefit to the fishery resource. The recommendation included conditions necessary to meet the net benefit:
 - a. All points of diversion proposed to be unused must be abandoned.
 - b. Prior to diverting water, the water user shall install a fish screening and/or by-pass device, as appropriate, at any new or existing points of diversion consistent with ODFW's design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screen and/or by-pass device meets ODFW's criteria. Additionally, prior to submitting the required Claim of Beneficial Use (CBU), the water user must obtain written approval from ODFW that the required screening and/or by-pass device was installed to

according to ODFW's criteria. The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, the the points of diversion consistent with ODFW's operational and maintenance standards.

- c. If the riparian area is disturbed in the process of developing a point of diversion, the water user shall be responsible for restoration and enhancement of the riparian area in accordance with ODFW's Fish and Wildlife Habitat Mitigation Policy, OAR 635-415.
- d. Upstream and downstream fish passage must not be impeded as a result of any structure built to divert water under these water rights.
- 45. Notice of the opportunity to comment on the recommendation to consent to injury of the instream water right was provided to the applicant and all persons who filed comments under OAR 690-380-4030. The notice of opportunity to comment was published on April 21, 2009, in the Department's weekly notice pursuant to OAR 690-380-5050(4).
- 46. On April 23, 2009, a cover letter and draft final order describing the changes proposed in Transfer Application T-6783 and the conditions as suggested by ODFW were sent to the applicant. The cover letter that accompanied the *draft* final order set forth a date of May 31, 2009, for the applicant to respond.
- 47. On June 2, 2009, the Department received an email response from the applicants agreeing to the conditions outlined in Finding of Fact #44.

Conclusions of Law

The Water Resources Department consents to injury of the instream water right under Certificate 59837. The changes proposed in Transfer Application T-6783, as modified by the conditions recommended by ODFW, are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000 and 690-380-5030.

Now, therefore it is ORDERED:

- 1. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 52677, 52678, 52679, 52680, 68760, 68761, 68762, 68763 and 72649 and any related decree.
- 2. Certificates 52677, 52678, 52679, 52680, 68760, 68761, 68762, 68763 and 72649 are cancelled. New certificates will be issued describing those portions of the rights not affected by this transfer.
- 3. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2010.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.

- 4. The quantity of water diverted at the new points of diversion shall not exceed the quantity of water lawfully available at the original points of diversion.
- 5. The former places of use of the transferred water shall no longer receive water as part of these rights.
- 6. Existing water use Permit S-53063 is diminished to supplemental irrigation for the incoming Simplot rights as described in #7, #19, #27 and #30,.
- 7. The water user shall maintain and operate the existing measurement device(s) and shall make such improvements as may be required by the Department.
- 8. All points of diversion proposed to be unused shall be abandoned.
- 9. If the riparian area is disturbed in the process of developing a point of diversion, the water user shall be responsible for restoration and enhancement of the riparian area in accordance with ODFW's Fish and Wildlife Habitat Mitigation Policy, OAR 635-415.
- 10. Upstream and downstream fish passage must not be impeded as a result of any structure built to divert water under these water rights.
- 11. Prior to diverting water, the water user shall install a fish screening and/or by-pass device, as appropriate, at any new or existing points of diversion consistent with ODFW's design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screen and/or by-pass device meets ODFW's criteria. Additionally, prior to submitting the required Claim of Beneficial Use (CBU), the water user must obtain written approval from ODFW that the required screening and/or by-pass device was installed to according to ODFW's criteria. The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, the points of diversion consistent with ODFW's operational and maintenance standards.
- 12. When satisfactory proofs of the completed changes are evaluated, new certificates confirming the rights transferred will be issued.
