ORDER APPROVING A CHANGE IN PLACE OF USE AND TYPE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7953 submitted by

WAYNE M. AND DONNA M. SPICER P.O. BOX 571 WINCHESTER, OREGON 97495.

The right to be modified, as evidenced by a portion of Certificate 62175, was perfected under Permit 46773 with a date of priority of MARCH 22, 1982. The right allows the use of the NORTH UMPQUA RIVER, a tributary of the UMPQUA RIVER, for IRRIGATION OF 2.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.03 cubic foot per second, if available at the authorized point of diversion: SE% SE%, SECTION 22, T 26 S, R 6 W, W.M.; 120 FEET NORTH AND 450 FEET WEST FROM THE SE CORNER OF SECTION 22, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SE% SW% 2.0 ACRES
AS PROJECTED WITHIN DLC 47
SECTION 23
TOWNSHIP 26 SOUTH, RANGE 6 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to change the type of use to RESERVOIR MAINTENANCE.

The applicant proposes to change the place of use to:

SECTION 23
TOWNSHIP 26 SOUTH, RANGE 6 WEST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1999.
- 2. The use of water for reservoir maintenance shall be limited to 0.03 cubic foot per second and shall not exceed 5.0 acre feet during the irrigation season March 1 to October 31.
- 3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 62175 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
