Findings of Fact

- 1. On February 26, 2013, the Department issued an order approving Permit Amendment Application T-11411. The order was recorded at Special Order Volume 89, Pages 62-64.
- 2. The order and superseding Permit G-16918 contains scrivener's errors in the proposed locations of Wells 1 and 2. The order and superseding permit erroneously describes the well locations as:

3. The correct well location descriptions are:

23 S	32 E	WM	18	SW SW	WELL 1 – 280 FEET NORTH AND 520 FEET EAST FROM THE SW CORNER OF SECTION 24
23 S	31 E	WM	24	NE NE	WELL 2 – 1120 FEET SOUTH AND 420 FEET WEST FROM THE NE CORNER OF SECTION 24

- 1. The order approving Permit Amendment Application T-11411, recorded at Special Order Volume 89, Pages 62-64 is amended.
- 2. Permit G-17038, in the name of STEVE RICKMAN, is issued to replace Permit G-16918, and incorporates the corrections approved by this order. Permit G-16918, in the name of STEVE RICKMAN, is no longer of any force or effect.
- 3. All other terms and conditions of Permit G-17038 remain the same.
- 4. All other provisions of the order are unchanged.
