ORDER APPROVING TRANSFER NO. 2460

On November 2, 1970, an application was filed in the office of the Water Resources Director by Publishers Paper Company for approval of a change in use theretofore made of water from Molalla River, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 36472, Volume 28, State Record of Water Right Certificates, in the names of W. G. Deardorff and V. C. Doppleb, describes a right which includes the use of not to exceed 0.24 cubic foot per second from Molalla River for irrigation of a certain 9.2 acres in NE<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub>, 2.0 acres in NW<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub>, 11.3 acres in SE<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub>, 14.4 acres in NW<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub> and 5.2 acres in SW<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub> of Section 29, Township 4 South, Range 2 East, W.M., with a date of priority of March 16, 1926.

Water for the said right is diverted from a point located 200 feet North and 700 feet East from the West Quarter Corner of Section 14, being within the  $SW_4^1$   $NW_4^1$  of Section 14, Township 5 South, Range 2 East, W.M.

The applicant herein, owner of the lands above described, proposes to change the use theretofore made of water and, without loss of priority, to use the said 0.24 cubic foot per second for the purpose of log deck sprinkling (including log deck fire protection) within the  $N^{1}_{2}$  SW $^{1}_{4}$ , SE $^{1}_{4}$  SW $^{1}_{4}$  and W $^{1}_{2}$  SE $^{1}_{4}$  of Section 29, Township 4 South, Range 2 East, W.M., said use being limited to the irrigation season of each year.

Notice of the application, pursuant to ORS 540.520(2), was published in the Molalla Pioneer, a newspaper printed and having general circulation in Clackamas County, Oregon, for a period of three weeks in the issues of October 11, 18 and 25, 1978.

Mr. Clifton R. King, Watermaster, has filed a statement to the effect that the proposed change in use theretofore made of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in use theretofore made of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in use theretofore made of water, as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1980.

It is FURTHER ORDERED that the certificate of water right recorded at page 36472, Volume 28, State Record of Water Right Certificates, is canceled; and in lieu thereof a new certificate be issued covering the balance of the right NOT involved in this proceeding; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.
