ORDER APPROVING A CHANGE IN POINT OF APPROPRIATION AND PLACE OF USE

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves TRANSFER 6252 submitted by

CLINTON AND MARY ANN BASEY P.O. BOX 343 CHILOQUIN, OREGON 97624

to use the waters of A WELL in the SILVER CREEK BASIN for the purpose of IRRIGATING 17.52 ACRES.

The right to be transferred, as evidenced by certificate 47620, was perfected under Permit G-6704 with a date of priority of JANUARY 6, 1976. The right is limited to 0.22 cubic foot per second, if available at the original well; NW 1/4 NW 1/4, SECTION 23, T 28 S, R 14 E, W.M.; 310 FEET SOUTH AND 1320 FEET EAST FROM THE NW CORNER OF SECTION 23, or its equivalent in case of rotation, measured at the well.

The new point of appropriation is located as follows:

NE 1/4 SE 1/4, SECTION 22, T 28 S, R 14 E, W.M.; 240 FEET SOUTH AND 780 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 22.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the new place of use is as follows:

NE 1/4 SE 1/4 17.52 ACRES SECTION 22 TOWNSHIP 28 SOUTH, RANGE 14 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- The proposed change shall be completed on or before October 1, 1991.
- 2. The quantity of water diverted at the new point of appropriation shall not exceed the quantity of water available from the original point of appropriation.
- 3. When required by the Department the water user shall install an inline flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. If needed to prevent injury to existing water rights, the well at the new point of appropriation shall be constructed to the well construction standards in effect as of the date of this order and must include an access port.
- 5. Water shall be acquired from the same aquifer as the original point of appropriation.
- 7. The following described lands shall no longer be irrigated as a part of this water right:

NE 1/4 NW 1/4 1.08 ACRES NW 1/4 NW 1/4 2.44 ACRES SW 1/4 NW 1/4 7.36 ACRES SE 1/4 NW 1/4 6.64 ACRES SECTION 23

TOWNSHIP 28 SOUTH, RANGE 14 EAST, W.M.

Certificate 47620 is hereby canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
