ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6089 submitted by

CLYDE W. PURCELL
728 NE GREENWOOD
BEND, OREGON 97701.

The rights to be modified were confirmed by decree of the Circuit Court of the State of Oregon for DESCHUTES County as evidenced by Certificates 33005 AND 33006. The decree is recorded in the Order Record of the Water Resources Director in Volume 9, at Page 362. The date of priority is OCTOBER 10, 1903.

The rights allow the use of DESCHUTES RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 8.0 ACRES AND 7.0 ACRES. These rights are limited to 0.20 cubic foot per second and 0.175 cubic foot per second, if available at the authorized point of diversion: SW $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 29, T 17 S, R 12 E, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The authorized place of use is located as follows:

NE $\frac{1}{4}$ NE $\frac{1}{4}$ 8.0 ACRES
NW $\frac{1}{4}$ NE $\frac{1}{4}$ 7.0 ACRES
SECTION 29
TOWNSHIP 17 SOUTH, RANGE 12 EAST, W.M.

The applicant proposes to change the place of use to:

NE $\frac{1}{4}$ NE $\frac{1}{4}$ 3.38 ACRES
NW $\frac{1}{4}$ NE $\frac{1}{4}$ 7.0 ACRES
SW $\frac{1}{4}$ NE $\frac{1}{4}$ 3.0 ACRES
SE $\frac{1}{4}$ NE $\frac{1}{4}$ 1.62 ACRES
SECTION 29
TOWNSHIP 17 SOUTH, RANGE 12 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.



THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1992.
2. The former place of use shall no longer be irrigated as a part of this water right.

Certificates 33005 and 33006 are cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
