### Authority

OAR 690-380-6020 establishes an application process and criteria for the review of extensions of time for the completion of changes authorized under water right transfers.

# Findings of Fact

- 1. On September 27, 2011, the Department received an application for extension of time for water right transfer T-10569 from Eric F. Scott, agent for The Confederated Tribes of the Grand Ronde Community of Oregon, transfer applicants.
- 2. The Water Resources Department issued an order approving Transfer Application T-10569 in the name of The Confederated Tribes of the Grand Ronde Community of Oregon, on January 26, 2010. The order was recorded in Special Order Volume 80, at Pages 142-146. The order set a transfer completion date of October 1, 2011.
- 3. The applicant has completed irrigation of the Pow Wow grounds (5.5 acres), using temporary equipment. Additional equipment has recently been purchased and placed into use, and development of the Pow Wow grounds facilities is still in progress.
- 4. To fully complete the change, it will be necessary for the applicant to get final approval for the full extent of use allowed under the transfer, verify the limits of irrigation and then proceed to conduct a final proof survey, and measure the pumping capacity.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

5. The applicant has requested that the time for completion of beneficial use be extended to October 1, 2015 to accomplish these tasks.

#### **Conclusions of Law**

Pursuant to OAR 690-380-6020, the Director of the Water Resources Department concludes the applicant has shown reasonable diligence to complete the transfer within the time period established by the order approving Transfer Application T-10569 and the requested time is reasonable.

## Now, therefore, it is ORDERED:

The time for completion of beneficial use authorized by T-10569 shall be extended to October 1, 2015.
