OF A GROUND WATER REGISTRATION
CLAIMED RIGHT IN THE NAME OF
ROBERT F. AND ISABEL R. MEYER

ORDER

On March 18, 1974, Robert F. and Isabel R. Meyer submitted an affidavit that they are the owners of lands claimed to have been irrigated as described in certificate of registration recorded at Page GR-1524, Volume 7, Ground Water Registration Record; that they have abandoned said claim of water right and request the same be canceled.


That part of the claimed right in question is for the use of not to exceed 51 gallons of water per minute from a well located North $52^{\circ} 40'$ East 35.75 chains from Southwest Corner Section 15, Township 11 South, Range 2 West, W.M., being within the $NE\frac{1}{4} SW\frac{1}{4}$, Section 15, Township 11 South, Range 2 West, W.M., for the irrigation of 3.1 acres within the $NE\frac{1}{4} SW\frac{1}{4}$, 3.7 acres within the $SE\frac{1}{4} SW\frac{1}{4}$, 1.2 acres within the $NW\frac{1}{4} SE\frac{1}{4}$, and 7.2 acres within the $SW\frac{1}{4} SE\frac{1}{4}$, Section 15, Township 11 South, Range 2 West, W.M.

That part of the claimed right described in said certificate for the appropriation of not to exceed 149 gallons of water per minute from said well for the irrigation of 13.7 acres within the $NE\frac{1}{4} SW\frac{1}{4}$, 5.1 acres within the $NW\frac{1}{4} SW\frac{1}{4}$, 4.9 acres within the $SW\frac{1}{4} SW\frac{1}{4}$, and 20.6 acres within the $SE\frac{1}{4} SW\frac{1}{4}$, Section 15, Township 11 South, Range 2 West, W.M., is not in question in this proceeding.

NOW, THEREFORE, it is hereby ORDERED that the claim of a water right for the use of not to exceed 51 gallons of water per mintue from a well located North $52^{\circ} 40'$ East 35.75 chains from Southwest corner Section 15, Township 11 South, Range 2 West, W.M., being within the $NE\frac{1}{4} SW\frac{1}{4}$, Section 15, Township 11 South, Range 2 West, W.M., for the irrigation of 3.1 acres within the $NE\frac{1}{4} SW\frac{1}{4}$, 3.7 acres within the $SE\frac{1}{4} SW\frac{1}{4}$, 1.2 acres within the $NW\frac{1}{4} SE\frac{1}{4}$, and 7.2 acres within the $SW\frac{1}{4} SE\frac{1}{4}$, Section 15, Township 11 South, Range 2 West, W.M., described in

certificate of registration recorded at Page GR-1524, Volume 7, Ground
Water Registration Record, is canceled.
