That part of the water right evidenced by said certificate for the appropriation of not to exceed 0.024 cubic foot per second of water from Pudding River for the irrigation of 1.80 acres in SW2 SW2, Township 4 South, Range 1 East, and 0.1 acre in the SE2 SE2, Section 12, Township 4 South, Range 1 West, W.M., is not in question in this proceeding.

NOW, THEREFORE, it hereby is ORDERED that the water right for the use of 0.224 cubic foot per second of water from Pudding River, with a priority date of May 5, 1950, for the irrigation of 4.65 acres in SW SW SW Section 7, and 13.3 acres in the NW NW NW Section 18, Township 4 South, Range 1 East, W.M., is canceled.

It is FURTHER ORDERED that the certificate of water right recorded at Page 20545, Volume 15, State Record of Water Right Certificates, is canceled, and in lieu thereof a new certificate be issued to Wm. Jensen covering that part of the water right not in question for the appropriation of not to exceed 0.024 cubic foot per second of water from Pudding River with a priority date of May 5, 1950, for the irrigation of 1.80 acres in SW2 SW2, Township 4 South, Range 1 East, and 0.1 acre in the SE2 SE4, Section 12, Township 4 South, Range 1 West, W.M.
