O R D E R
APPROVING APPLICATION

On July 17, 1940, Steven L. Steidl of Bend, Oregon, filed an application for approval of a change in place of use of water from Deschutes River.

In the adjudication proceedings involving the determination of the relative rights to the use of the waters of Deschutes River and its tributaries, a water right was recognized in the name of Steidl & Tweet for the irrigation of, among other lands, 20 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 29, Township 17 South, Range 12 East, W. M., from Deschutes River, with a date of priority of October 10, 1903.

The applicant herein, owner of the above-described land, proposes to transfer the water right appurtenant thereto to 10 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20, and 10 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 29, Township 17 South, Range 12 East, W. M.

Notice by publication as provided by Section 47-712, Oregon Code 1935 Supplement, was not given in connection with this application for the reason that said section provides that notice is not required in applications for only a change in place of use of water.

It appears that such change in place of use can be made without injury to existing rights and the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use of water be and the same hereby is approved and the water right hereinbefore described as appurtenant to 20 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 29,

Township 17 South, Range 12 East, W. M., be severed therefrom and simultaneously and without loss of priority transferred to 10 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20, and 10 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 29, Township 17 South, Range 12 East, W. M.

It is FURTHER ORDERED that complete application of water to beneficial use on said lands be made on or before October 1, 1941, or such extension of time as may be granted by the State Engineer for good cause shown.

It is FURTHER ORDERED that a certificate of water right shall be issued to Steven L. Steidl or his successor-in-interest to said lands when and at the time certificates of water right are issued in connection with the Deschutes River adjudication proceedings.
