## ORDER APPROVING A CHANGE IN PLACE OF USE

## (SWITCH IN PRIORITY DATES)

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6482 submitted by

RON VANDECOEVERING 11607 BARON ROAD NE MT. ANGEL, OREGON 97362.

The first right to be modified, as evidenced by a PORTION of Certificate 22924, was perfected under Permit 19816 with a date of priority of SEPTEMBER 1, 1950. The right allows the use of BUTTE CREEK, a tributary of PUDDING RIVER, for IRRIGATION OF 9.0 ACRES. This right is limited to 0.11 cubic foot per second, if available at the authorized point of diversion:  $NE^{\frac{1}{4}}$   $NW^{\frac{1}{4}}$ , as projected within Newman DLC 73, SECTION 25, T 5 S, R 1 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The second right to be modified, as evidenced by Certificate 40315, was perfected under Permit 33311 with a date of priority of FEBRUARY 27, 1968. The right allows the use of BUTTE CREEK, a tributary of PUDDING RIVER, for IRRIGATION OF 9.0 ACRES. This right is limited to 0.11 cubic foot per second, if available at the authorized point of diversion:  $NE^{\frac{1}{4}}$ , as projected within Newman DLC 73, SECTION 25, T 5 S, R 1 W, W.M.; 3500 FEET NORTH AND 1750 FEET EAST FROM THE NW CORNER OF EASTHAM DLC 63, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and  $2\frac{1}{2}$  acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

1. The proposed change shall be completed on or before October 1, 1992.

Certificates 22924 and 40315 are cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, new certificates confirming these water rights will be issued.
