Certificate 74145, Deschutes County            )

ORS 537.348 establishes the process in which a water right holder may submit a request to lease an existing water right for instream purposes. OAR Chapter 690, Division 077 implements the statutes and provides the Department's procedures and criteria for evaluating instream lease applications.

**Findings of Fact**

1. On January 24, 2007, Shari Biggs, SID, and the DRC filed an application to lease a portion of Certificate 74145 to instream use. The Department assigned the application number IL-799.
2. On February 27, 2007, the Department issued an order approving this instream lease application, as evidenced by Special Order Volume 71, Page 216. Following issuance of this order a scrivener's error was identified. The order identified that the lease was to commence on April 1, 2006. The order also identified that to terminate the lease early the lessor needed to provide notice by April 1 of each year. This is incorrect. The correct date on which the lease commenced is April 1, 2007. Also, the correct date for notice of early termination is March 1 of each year. This order is being issued to correctly describe these dates and supersedes Special Order Volume 71, Page 216.
3. The right to be leased has been clarified from the lease application and is as follows:  
**Certificate:** 74145  
**Priority Date:** September 1, 1899  
**Season of Use:** April 1 to November 1, further limited as follows:  
April 1 to May 1 and Oct. 1 to Nov. 1 described herein as Season 1  
May 1 to May 15 and Sept. 15 to Oct. 1 described herein as Season 2

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

 Rate: Season 1 (limited to 1/83<sup>rd</sup> Cubic Foot per Second (CFS)/acre)

- The lease application includes the information required under OAR 690-077-0077(3). The Department provided notice of the lease application pursuant to OAR 690-077-0077(6). No comments were received.
- The instream use is as follows:  
Deschutes River, tributary to the Columbia River

**Instream Reach:** From the Swalley Main Canal Diversion #3 (as described in Finding of Fact #3) to Lake Billy Chinook

- Other conditions to prevent injury and enlargement are:

The amount of water to be leased instream under certificate 74145 does not include a 43% transmission loss associated with this right when used for its originally authorized purpose. The transmission loss may not be leased and protected instream.

- Based upon review of the application, comments received, information provided by the Department's Watermaster, and other available information, the Department finds that the

lease will not result in injury or enlargement. This finding is made through an abbreviated review recognizing that the lease may be modified or revoked under OAR 690-077-0077 if the Department later finds that the lease is causing injury to any existing water right or enlargement of the original right.

8. If a right which has been leased is later proposed to be leased again or transferred to an instream use under ORS 537.348 and OAR 690-077-0070 or OAR 690-077-0075 a new injury review shall be required. Transfers will be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380 and Division 077. Approval of this lease does not establish a precedent for approval of future leases or transfers.
9. The lease commenced on April 1, 2007, and will terminate on October 31, 2011.
10. The Lessor has requested the option of terminating the lease early with written notice to the Department.

#### CONCLUSIONS OF LAW


The Department concludes that the lease will not result in injury or enlargement, OAR 690-077-0077. The lease conforms to the applicable provisions of OAR 690-077-0015.

#### ORDER

Therefore, it is ORDERED:

1. That the Lease as described herein is APPROVED.
2. The former place of use will no longer receive water as part of this right during the term of the lease.
3. The lease will terminate on October 31, 2011. The Lessor has the option of terminating the lease each year, with notification to the Department by March 1 of each year, and before any use has occurred on the property.
4. This correcting order supersedes Special Order Volume 71, Page 216.
