Authority

ORS 540.570 to 540.580 establishes the process in which a district may submit a request to transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department’s procedures and criteria for evaluating district transfer applications.

Findings of Fact

1. On March 6, 2017, Willow Creek District Improvement Company filed a district transfer application to permanently change the place of use under Certificates 82491, 82490, and Surface Water Permit S-54980 and Groundwater permit G-15586. The Department assigned the application number T-12605.
2. Notice of the District Permanent Transfer Application was published on March 14, 2017, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notices.
3. On July 13, 2017, and again on August 3, 2017, the Department contacted the agent for the applicant with regard to deficiencies in the application.
4. On August 8, 2017, the applicant’s agent provided amended application pages and a map addressing the deficiencies in the application.
5. The portion of first the right to be transferred is as follows:
Certificate: 82491 in the name of ELMER E. PADBERG (perfected under Permit G-6828)
Use: IRRIGATION OF 327.7 ACRES
Priority Date: OCTOBER 1, 1973
Rate: 2.05 CUBIC FEET PER SECOND

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Within 20 days after this final order is issued (i.e., mailing date), the district or any protestant may file with the commission exceptions to the final order. The commission shall issue an order granting or denying the exceptions within 30 days after receiving the exceptions. ORS 540.580(10).

Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

13. The Department finds that the district permanent transfer application satisfies the criteria of OAR 690-385-4000 and contains the information required under OAR 690-385-4200 and includes maps meeting the requirements of OAR 690-385-4300.

14. The water rights are subject to transfer as defined in OAR 690-385-0100(17).

15. The proposed change in place of use will not result in enlargement of the right.

16. The proposed change in place of use as conditioned will not result in injury to other water rights.


Conclusions of Law

The proposed changes in place of use as proposed in Transfer Application T-12605 satisfy the requirements of ORS 540.574(3) and 540.580.

Now, therefore, it is ORDERED:

1. The proposed changes in place of use to the water right evidenced by Certificates 82491, 82490, and Water Use Permits S-54980 and G-15586 are approved.
2. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 82491, 82490, and water use Permits S-54980, G-15586 and any related decree.
3. The former places of use shall no longer be irrigated as part of this water right.
4. Water use measurement conditions:
 - a. **Before water use may begin** under this order, the water user shall install totalizing flow meters, or, with prior approval of the Director, other suitable measuring devices, at each point of diversion (new and existing).
 - b. The water user shall maintain the meters or measuring devices in good working order.
 - c. The water user shall allow the Watermaster access to the meters or measuring device(s); provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
5. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2018**. A Claim of Beneficial Use shall be submitted by Willow Creek District Improvement Co. to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
6. Water right Certificates 82491, 82490, and water use Permits S-54980, G-15586 are modified. The Department will issue superseding Certificates describing the rights when it determines it is necessary for record keeping.
