Authority

ORS 537.211 establishes the process in which a water right permit holder may submit a request to change the point of appropriation and/or place of use authorized under an existing water right permit.

Applicant

Findings of Fact

- 1. On July 29, 2013, CITY OF PRINEVILLE filed an application for an additional point of appropriation under Permit G-16146. The Department assigned the application number T-11647.
- 2. On June 25, 2008, the Department approved Permit Amendment T-10378, entered at Special Order Volume 75, Page 245, amending Permit G-16146 for a change in points of appropriation, additional points of appropriation, and a change in place of use.
- 3. Notice of the application for the permit amendment was published in the Department's weekly notice on August 20, 2013, and in the Central Oregonian newspaper on October 29 and November 5, 2013, pursuant to ORS 540.520(5). No comments were filed in response to the notices.
- 4. On September 6, 2013, the applicant's agent amended the application to correct an error in the location description of the proposed well.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

5. Permit Amendment Application T-11647 proposes an additional point of appropriation approximately 1500 feet from the existing points of appropriation to:

Permit Amendment Review Criteria

- 6. The change would not result in injury to other water rights.
- 7. The change does not enlarge the permit.
- 8. The change does not alter any other terms of the permit.

Conclusions of Law

The additional point of appropriation proposed by Permit Amendment Application T-11647 is consistent with the requirements of ORS 537.211.

Now, therefore, it is ORDERED:

- 1. The additional point of appropriation proposed by Permit Amendment Application T-11647 is approved.
- 2. Permit G-17089, in the name of CITY OF PRINEVILLE, is issued to replace Permit G-16146, and incorporates the amendments approved by this order, and the order approving Permit Amendment T-10378. Permit G-16146, in the name of CITY OF PRINEVILLE, is no longer of any force or effect.
- 3. The combined quantity of water diverted at the new point of appropriation, together with that diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 4. Prior to water use from the proposed point of appropriation, the permittee shall install a totalizing flow meter on each well. The totalizing flow meter must be installed and maintained in good working order consistent with those standards identified in OAR 690-507-645 (1) through (3). The permittee shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water use information, including the place and nature of use of water under the permit.

The permittee shall allow the watermaster access to the meters; provided however, where the meter is located within a private structure, the watermaster shall request access upon reasonable notice.

- 5. Water shall be acquired from the same aquifer as the original points of appropriation.
- 6. All other terms and conditions of Permit G-17089 remain the same.
