Harris, Dennis McClaughry, Sam Ramp, Peter Sproed and Jim Pfau, Edward Hynes, Anna McGuire, Gordon Turnidge and George Schmidt, Robert C. and Eva J. Meye, Fred, Anna and Clarence Schmidt and Norman Craig Klampe have submitted affidavits that at the time of submittal they were the owners of certain water rights and the lands to which the water rights are appurtenant; that they have abandoned any and all interest in and to the said water rights and request the same be canceled.

The water rights in question are portions of the right described by the certificate recorded at page 7780, Volume 7, State Record of Water Right Certificates, in the names of E.A. and J.O Hayes, and are for the use of not to exceed 3.10 cubic feet per second of water from Little Pudding River, with a date of priority of June 17, 1924, for irrigation of a certain 0.20 acre in NW 1/4 NW 1/4 and 3.30 acres in SW 1/4 NW 1/4, Section 7, Township 6 South, Range 1 West, WM; 1.40 acres in NE 1/4 SE 1/4, 4.90 acres in SW 1/4 SW 1/4, 1.50 acres in NE 1/4 NE 1/4, 15.60 acres in SW 1/4 NE 1/4, 26.60 acres in SE 1/4 NE 1/4, 22.30 acres in NE 1/4 SW 1/4, Section 12; 4.30 acres in NW 1/4 SE 1/4 and 1.70 acres in SW 1/4 NW 1/4, Section 13; 9.30 acres in NE 1/4 NE 1/4, 16.92 acres in SW 1/4 NE 1/4, 27.42 acres in SE 1/4 NE 1/4, 19.00 acres in NW 1/4 SW 1/4, 3.00 acres in NE 1/4 SW 1/4, 25.31 acres in SE 1/4 SW 1/4, 0.75 acre in NE 1/4 SE 1/4, 4.12 acres in NW 1/4 SE 1/4 and 4.20 acres in SW 1/4 SE 1/4, Section 14; 10.30 acres in NE 1/4 NW 1/4, Section 23, Township 6 South, Range 2 West, WM.

ORS 540.621 provides that: "Whenever the owner of a perfected and developed water right certifies under oath to the Water Resources Director that the water right has been abandoned by him and that he desires cancellation thereof, the Water Resources Director shall enter an order canceling the water right."

NOW, THEREFORE, it hereby is ORDERED that the said water rights, being portions of the right described by the certificate recorded at page 7780, Volume 7, State Record of Water Right Certificates, are canceled.

It is FURTHER ORDERED that the said certificate of water right is canceled, and in lieu thereof a new certificate be issued to describe the balance of the water right NOT involved in this and prior cancellation proceedings.
