ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7019 submitted by

MILLER FORESTS, INC. P.O. BOX 12395 SALEM, OREGON 97309.

The first right to be modified, as evidenced by Certificate 32215, was perfected under Permit G-1552 with a date of priority of MARCH 7, 1960. The right allows the use of A WELL, in the WILLAMETTE RIVER BASIN, for IRRIGATION OF 77.6 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.81 cubic foot per second, if available at the original well; SE% SW%, SECTION 28, T 6 S, R 3 W, W.M.; 19% CHAINS NORTH AND 9% CHAINS WEST FROM THE S% CORNER, SECTION 28, or its equivalent in case of rotation, measured at the well.

The second right to be modified, as evidenced by Certificate 44983, was perfected under Permit G-4982 with a date of priority of NOVEMBER 10, 1971. The right allows the use of A WELL, in the WILLAMETTE RIVER BASIN, for IRRIGATION OF 72.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.90 cubic foot per second, if available at the original well; NW% NE%, SECTION 28, T 6 S, R 3 W, W.M.; 860 FEET SOUTH AND 1860 FEET WEST FROM THE NE CORNER, SECTION 28, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized places of use are as follows:

TOWNSHIP 6 SOUTH, RANGE 3 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes additional points of appropriation to:

WELL 1 - NE% NW%, SECTION 28, T 6 S, R 3 W, W.M.; 110 FEET SOUTH AND 710 FEET WEST FROM THE N% CORNER, SECTION 28.

WELL 3 - SE% NW%, SECTION 28, T 6 S, R 3 W, W.M.; 1660 FEET SOUTH AND 1280 FEET WEST FROM THE N% CORNER, SECTION 28.

WELL 4 - NW% SW%, SECTION 21, T 6 S, R 3 W, W.M.; 1940 FEET NORTH AND 1810 FEET WEST FROM THE S% CORNER, SECTION 21.

WELL 5 - SE% SW%, SECTION 28, T 6 S, R 3 W, W.M.; 3980 FEET SOUTH AND 660 FEET WEST FROM THE N% CORNER, SECTION 28.

WELL 6 - NW% NE%, SECTION 28, T 6 S, R 3 W, W.M.; 860 FEET SOUTH AND 1860 FEET WEST FROM THE NE CORNER, SECTION 28.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1998.
- 2. The quantity of water diverted at the new points of appropriation (well), together with the quantity diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available from the original points of appropriation.

- 3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original points of appropriation.

Certificates 32215, 44983 are cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
