On January 7, 1947, Ralph H. Cake, 230 S. W. Broadway, Portland, Oregon, filed an application for a change in place of use of water from Deschutes River, pursuant to the provisions of Section 116-606, O. C. L. A.

By decree of the Circuit Court for Deschutes County dated December 17, 1932, in the matter of the determination of the relative rights to the use of the waters of Deschutes River and its tributaries, a water right was recognized in the name of the Deschutes Reclamation and Irrigation Company for the irrigation of, among other lands, 22 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ and 20 acres in the SE $\frac{1}{4}$ Section 7 and 13 acres in Lot 1, $(NW_{\frac{1}{4}}^{1} NW_{\frac{1}{4}}^{1})$ Section 18, Township 17 South, Range 12 East, W. M., from Deschutes River with a date of priority of September 1, 1899.

Ralph H. Cake, owner of the above described land, proposes to transfer the water right appurtenant thereto, without loss of priority, to 20 acres in the SW_{4}^{1} SE_{4}^{1} , Section 7, 10 acres in NE_{4}^{1} NE_{4}^{1} , 10 acres in the SE_{4}^{1} NE_{4}^{1} , 5 acres in the NE_{4}^{1} SW_{4}^{1} and 10 acres in the SW_{4}^{1} SE_{4}^{1} , Section 18, Township 17 South, Range 12 East, W. M.

Notice by publication, as provided by Section 116-606, O. C. L. A., was not given in connection with this application for the reason that said section provides that notice is not required in applications for only a change in place of use of water.

The Board of Directors of the Deschutes Reclamation and Irrigation Company have submitted their approval to the proposed transfer.

No objections having been filed, and it appearing that the proposed change in place of use of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it is hereby ORDERED that the proposed change in place of use of water be and same hereby is approved, and that the water rights hereinbefore described as appurtenant to 22 acres in the NET SET and 20 acres in the SET SET, Section 7, and 13 acres in Lot 1 (NWT NWT), Section 18, Township 17 South, Range 12 East, W. M., with a date of priority of September 1, 1899, be severed therefrom and simultaneously and without loss of priority transferred to 20 acres in the SWT SET, Section 7, 10 acres in the NET NET, 10 acres in the SET NET, 5 acres in the NET SWT and 10 acres in the SWT SET, Section 18, Township 17 South, Range 12 East, W. M.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before June 30, 1947.
